# **Chapter 1**

## **Tabling of Evidence**

---

**This Chapter sets out the Committee’s decision to table all evidence, submissions and communications that informed the Committee as to the issues raised by the Inquiry, unless, with respect to particular items, there exists a very good reason not to.**

---

### **Background**

- 1.1 On 1 March 2012, the Legislative Assembly agreed to direct the Economics and Industry Standing Committee to:

*investigate and report by 21 June [2012] on the 2011 Kimberley Ultramarathon’ event held by RacingThePlanet—RacingThePlanet—which resulted in injuries to a number of participants. The investigation will include:*

- a) *whether RacingThePlanet took all reasonable steps to identify and reduce risks and maintain the safety of competitors, employees, contractors, spectators and volunteers in the preparation for and the running of the event and in responding to the fire and the injuries, including access to medical support and evacuations;*
- b) *the extent to which the terms and conditions applied by an event organiser to employees, volunteers and competitors and any associated sponsorship agreement with WA Tourism should reasonably protect the safety and interests of competitors, employees, contractors, volunteers and spectators;*
- c) *insurance and civil liabilities matters and the appropriateness of the Civil Liability Act 2002 (Western Australia) provisions regarding liability of operators and organisation of recreational activities particularly of a high risk nature;*
- d) *the extent to which WA Tourism adequately assessed the qualifications, capability, experience, and capacity of RacingThePlanet to organise, promote and run the event safely and with appropriate protections to competitors,*

*employees, contractors, volunteers and spectators and the extent to which these should be assessed for future events;*

- e) *the role and actions of Western Australian government departments and agencies, including WA Tourism, DEC, FESA, Police and Health departments and local governments in respect of the event and the protection and rescue of competitors, employees, contractors, volunteers and spectators; and*
  - f) *whether there are measures that should be taken by government to ensure the risks including bush fires in remote areas in the context of extreme sporting events are adequately identified and addressed.*
- 1.2 The Assembly simultaneously agreed to co-opt the Member for Midland, the Hon Michelle Roberts MLA, to the Committee for the duration of the Inquiry.<sup>1</sup>
- 1.3 On 13 June 2012, the Committee requested from the House, and was granted, an extension of the reporting deadline to Thursday, 16 August 2012 in order to deal with the substantial amount of evidence that was collected during the Inquiry.
- 1.4 On 16 August 2012 the Chair of the Committee, Dr Mike Nahan MLA, tabled Report No. 13 – *Inquiry into the 2011 Kimberly Ultramarathon*, with the Legislative Assembly (**the Committee's Report**).

### **Tabling of formal evidence and other documents**

- 1.5 Standing Order 278(2) provides:
- Unless the committee resolves otherwise, relevant formal evidence taken by the committee will be tabled with the report and it may also be accompanied by minutes of proceedings and other documents.*
- 1.6 Such were the time pressures involved in tabling the Committee's Report on 16 August 2012 that the Committee deferred consideration of what evidence and documentation it would table with the House until after the Committee's Report had been tabled.
- 1.7 The Committee has now resolved that all evidence, submissions and communications that informed the Committee as to the issues raised by the Inquiry should be tabled so as to inform the House, unless there is a very good reason not to.

- 1.8 All of the material tabled with this Report today has been authorised by the Committee to be tabled with the House as part of the Inquiry.
- 1.9 Evidence taken *in camera* has not been tabled.
- 1.10 Evidence taken where the Committee has agreed to a request from the contributor to keep the material confidential has not been tabled.
- 1.11 Correspondence and communications which had little probative value and/or were largely argumentative, speculative or peripheral to the issues raised by the Inquiry have not been tabled.
- 1.12 Some evidence, submissions and communications have been redacted to remove information of a personal nature.
- 1.13 Specific comment is made as to the following tabled material.

### **Video footage**

- 1.14 Eventscorp (a division of Tourism WA) entered into an agreement with Sydney-based film company, Beyond Action, to film the 2011 Kimberley Ultramarathon as part of a proposed documentary series that would be distributed internationally to highlight the race and the scenery of the state's north-west.
- 1.15 Beyond Action proceeded to attend and shoot footage of the 2011 Kimberley Ultramarathon.
- 1.16 Tourism WA provided the Committee with 19 DVDs of footage shot by Beyond Action of the 2011 Kimberley Ultramarathon.
- 1.17 All of the footage was viewed by the Committee's Secretariat, and excerpts viewed by the Committee as part of its deliberations and preparation of the Committee's Report.
- 1.18 The video footage was of great assistance to the Committee in addressing the issues raised in the Inquiry.
- 1.19 The Committee resolved that the totality of the video footage it received be tabled save for where moments of a personal nature have been filmed.

### **WA Police Report**

- 1.20 The WA Police provided to the Committee a compilation of documents which was entitled "WA Police Report". The WA Police Report was delivered to the Committee as a large TIFF file (34 MB) burnt onto a CD. The WA Police Report contains, amongst other things, a number of witness statements.

- 1.21 The witness statements were of great assistance to the Committee in addressing the issues raised in the Inquiry.
- 1.22 During the course of the Inquiry the deponents of the witness statements were advised that, as with all forms of evidence gathered during an Inquiry, reference may be made to parts of their witness statement in the Committee's final report and may be tabled in Parliament at the conclusion of the report along with the other evidence it has collected during the Inquiry.
- 1.23 The Committee considers it essential that the House be provided with the witness statements, and accordingly has resolved to table the entirety of the WA Police Report, which contains these witness statements, with suitable redactions of information of a personal nature.

### **RacingThePlanet's Risk Management Plan**

- 1.24 On 1 June 2012 RacingThePlanet provided a copy of its Risk Management Plan (**the Plan**) to the Committee accompanied by a request that the Committee treat the Plan as confidential. RacingThePlanet submitted that Plan comprised valuable intellectual property the content of which has been developed and formulated over the 10 years during which RacingThePlanet had conducted remote location footraces.
- 1.25 The Plan is referred to and is the subject of analysis in the Committee's Report.
- 1.26 After having regard to:
  - the extent to which the Plan is referred to and analysed in the Committee's report;
  - the need to inform the House of the basis upon which the Committee conducted its deliberations; and
  - the submission of RacingThePlanet that the Plan comprised valuable intellectual property the content of which has been developed and formulated over the 10 years during which RacingThePlanet had conducted remote location footraces,

the Committee resolved to table the Plan, and well as the versions of the Plan that RacingThePlanet provided to FESA, the WA Police and Tourism WA.

### **Emergency phone calls**

- 1.27 The Committee resolved to table the audio recordings of all emergency phone calls it received from FESA, WA Police, St John's Ambulance and Telstra.

### **Tabling of non-digital media**

- 1.28 Where possible the material tabled has been tabled in the form in which it was presented to the Committee. For example, letters which have been received by the Committee as submissions are tabled in their original paper form.
- 1.29 If however a submission contained a private phone number or address, the pages containing this information have been removed and replaced by pages with this information blanked out.

### **Tabling of digital media**

- 1.30 The Committee received large amounts of information in digital form, such as:
- video files
  - audio files
  - emails
  - PDFs
  - graphic files; and
  - zipped files.
- 1.31 All of the digital media that the Committee has resolved to be tabled is contained on an external hard drive. This hard drive has physically been tabled in the House.
- 1.32 Where possible, and in addition to the external hard drive, digital material has been tabled in the form in which it was presented to the Committee.
- 1.33 For example, the Committee resolved to table (subject to redaction of material of a personal nature) all of the 19 DVDs it received from Tourism WA. Of the 19 DVDs, 17 did not need redaction, and have thus been tabled in their original DVD form.
- 1.34 It can be appreciated that with respect to the remaining 2 DVDs, the original discs could not be tabled.
- 1.35 In this regard the approach of the Committee was to convert the digital video footage on the 2 DVDs into electronic media files, and use a video editing software package to remove the personally sensitive material.

## Chapter 1

- 1.36 The redacted video files were then transferred to the tabled external hard drive.
- 1.37 For the sake of completeness:
  - the external hard drive also includes electronic copies of all evidence and submissions that have been tabled in their original paper form;
  - the external hard drive contains an excel spreadsheet which lists all of the tabled documents and contains a link to an electronic version of each tabled document, which is stored on the external hard drive.
