## 311. Mr M. McGOWAN to the Minister for Education and Training:

Will the minister please advise the House how much of an additional benefit \$47,700 could deliver to the education and training budget?

# Mr A.J. CARPENTER replied:

I thank the member for Rockingham for the question. Incidentally, \$47 700 is the amount of money that is paid as an allowance to the Deputy Leader of the Opposition in this State. An amount of \$47 700 is being paid to the Leader of the National Party, and an amount of \$47 700 is currently being paid to the Deputy Leader of the Opposition. According to the press release that the coalition leaders put out last week, the Leader of the National Party is the Deputy Leader of the Opposition, and according to the press release that they put out about their shadow Cabinet, the Leader of the National Party is the Deputy Leader of the Opposition. At \$19 each, the amount of \$47,700 would pay for the screening of 2,500 newborn babies.

Mr A.J. CARPENTER: Mr Speaker, I ask a rhetorical question of the Leader of the Opposition: given the information that has been released, is \$47 700 the price of the member for Mitchell's loyalty, or is the Leader of the Opposition drawing upon some other precedent?

Mr Speaker, \$47 700 could provide a lot of benefit to children with disabilities in the education system. Is a fraud being perpetrated on the public under the current arrangements that members opposite have settled on? Who is the Deputy Leader of the Opposition? Is this a rort or is it pure hypocrisy? The price that the Leader of the Opposition is paying, at the expense of children, for the loyalty of the Deputy Leader of the Opposition is \$47 700.
