199. Hon. C.L. Edwardes to the Minister for Health

I refer the Minister to the answers to questions on notice Nos. 1572 and 1637 and ask -

- (a) why did the Minister not provide the information requested when every other Minister has been able to provide the same information asked of them;
- (b) is the Minister, by his refusal to provide the information, deliberately concealing or hiding information, in particular the costs of reviews, committees, inquiries and taskforces from the public of Western Australia;
- (c) does the Minister, by his refusal to provide this information, think the people of Western Australia are incapable of understanding the costs involved
- (d) does the Minister, by his refusal to provide this information, think that the people of Western Australia will see that the Minister is wasting health funding on reviews, committees, inquiries and taskforces while service delivery suffers;
- (e) will the Minister now provide the information; and
- (f) if not, is this not a breach of the Gallop Government's pre-election commitment to accountability and transparency?
