#### *Supplementary Information Request No. A4*

*Question: Mr Barnett asked the minister to provide information about the costs of the Burrup negotiations to date and an indication of the estimated costs for the coming financial year.*

*Answer:* Payments in relation to negotiations to resolve native title matters on the Burrup Peninsula, to 5 June 2002, was \$360,911.17. This figure includes financial assistance provided to native title parties to enable them to participate in negotiations, as well as the contract fee paid, to 5 June 2002, of the State's lead negotiator, Mr Chris Athanasiou.

As it is intended that negotiations will be concluded by the end of the current financial year, it is estimated that limited or no costs will be incurred in the 2002-03 financial year.

#### *Supplementary Information Request No. A5*

*Question: Mr Barnett asked the minister to provide detail of the titles granted over Hearson Cove, to allow for construction of the North West Shelf Project, including the dates and purposes of those titles.*

*Answer:* No titles have previously been issued over the Hearson Cove beach area to allow for the construction of the North West Shelf Project.

In July 1980 a temporary lease was granted from unallocated Crown land north of Hearson Cove, to the North West Shelf Joint Venture participants, for the purpose of a "Construction Camp and Water Supply". The lease was granted on an annual renewable basis. A more formal special purpose lease was granted to the Joint Venture participants on 16 July 1982 for the "Construction, provision, use, operation and maintenance of a construction camp and associated facilities, and for ancillary and incidental purposes in accordance with approved proposals". That lease was terminated on 18 July 1991.

The three native title parties involved in the negotiations regarding the Burrup Peninsula – including Hearson Cove and its surrounds - have applications for a determination of native title lodged with the Federal Court and registered by the National Native Title Tribunal. As such, all three native title parties have the right to negotiate under the *Native Title Act 1993*.

#### *Supplementary Information Request No. A6*

*Question: Mr Marlborough asked the minister to provide details of any urban development in the Kalgoorlie region that is subject to delay as a result of native title.*

*Answer:* No urban developments in Kalgoorlie are currently subject to delay as a result of native title. The major area of future urban development in Kalgoorlie is the North-West Sector, which will provide twenty years of land supply for Kalgoorlie. However, the processes under the Native Title Act for this proposal were completed in June 1999. There are other small urban infill proposals in Kalgoorlie, and these are proceeding in accordance with the usual statutory processes, including native title.

*Question: Mrs Edwardes asked for the number of enquiries to the Department of the Premier and Cabinet relating to the industrial relations legislation.*

*Answer:* The number of enquiries received in relation to Industrial/Labour Relations was approximately 200-250.

*Supplementary Information Request No. A51*

*Question: Mr Masters asked the Premier for a comparison of the science and innovation budget allocations of the previous Government and the current Government.*

*Answer:* It has not been possible to obtain detailed information on the 4 year budget allocation for science and innovation under the previous Government. However, a comparison of the 2001-02 and 2002-03 budgets can be provided.

The 2001-02 Budget and Appropriation Summary in the published budget statements for the Department of Industry and Technology showed the 2001-02 budget estimate for the purchase of Output 3, Innovation and

Technology Services as \$41.756 million. The Department of Industry and Technology has provided the following detail of this allocation:

The activities and associated funding that were transferred to the Department of the Premier and Cabinet are those listed above under the heading of Science and Research Services, with a total allocation of \$24.525 million.

The other activities have remained in the Department of Industry and Technology as they are considered to be technology rather than science based. Some are included in that Department's Output 3, Innovation and Technology Services, the total cost of which is shown as \$6.327 million for 2002-03. Others, including Communication Services, Technology Park Operations, Internet Services and SPIRIT, have been transferred to other Outputs. The Department of Industry and Technology is not able to provide details of 2002-03 budget allocations for these activities as their budget was developed at a higher level and funding for these activities is aggregated with other activities.

The 2002-03 Budget Statements show the estimate for the purchase of Science and Innovation (Output 9 of the Department of the Premier and Cabinet) as \$28.904 million. In addition, \$5 million has been allocated as administered revenue.

In summary, the total 2001-02 allocation to the Science and Innovation activities to be transferred to the Department of the Premier and Cabinet was \$24.525 million. For 2002-03, the total appropriation to the Science and Innovation Output is \$33.904 million, an increase of \$9.379 million.

*Supplementary Information Request No. A52*

*Question: Mr Masters asked the Premier for details of the amounts allocated to science education, science capability and research in State Government under the science budget.*

*Answer:* The following summary shows the proposed allocations from Innovate Western Australia to science education, science capability and research in State Government.

#### **Science Education**

HECS Scheme - \$3.6 million over the 4 year period 2002/03 - 2005/06.

This program will pay or reimburse the Higher Education Contribution Scheme (HECS) fees of people who have completed a Diploma in Education and take up positions as physics and chemistry teachers. It covers the payment of the HECS liability, from the second year of university study onwards, for those science teachers who have completed second year tertiary studies in physics, chemistry and mathematics. Funding will be provided for recruitment of 160 science teachers over the next four years.

Science Talent Search - \$0.24 million over the 4 year period 2002/03 - 2005/06.

---

Funding for the Science Teachers Association of WA, Science Talent Search and the Consortium of Professional Teachers Associations' Value Adding Quest.

### **Science Capability**

Western Australian Premier's Fellowships - \$2 million over the 4 year period 2002/03 - 2005/06.

Grants to attract excellent researchers from overseas and interstate involving local organisations or centres and to seed the establishment of new centres. Each fellowship will be worth \$250,000 pa.

### **Research in State Government**

Agency Grants - \$1.75 million over the 4 year period 2002/03 - 2005/06.

Grants to stimulate cross agency research collaboration in areas of strategic priority for Western Australia. These would require a minimum of two State Government research agencies as joining applicants and at least one external partner from academe, CSIRO or industry.

*Supplementary Information Request No. A53*

*Question: Mrs Edwardes asked the Premier to explain why the Government would increase the number of FTEs in the Native Title Unit in the forthcoming year, whether the increase in the Office of Native Title budget allocation was due mainly to this increase in FTEs, and to provide the names and skills of staff who would or already had been recruited into the Department.*

*Answer:* The additional funding is made up of the following components:

#### Administration

The role and functions of the Native Title area have been expanded and the previous budget base was inadequate to enable the delivery of the required outcomes. The increased funding provides for an additional 8 positions. People with experience in Native Title, and in particular people with mediation and negotiation skills, will be recruited. In addition, people with strong financial management skills will be recruited to ensure that agreement funding is appropriately managed.

#### Agreements

Funding has been increased to cater for an anticipated increase in the number of native title agreements. In addition, funding had previously been approved for 2002-03 and 2003-04 but not beyond and this has now been extended to the outyears.

#### Title Searches

Funding for title searches was transferred from the Crown Solicitor's Office to the Department of the Premier and Cabinet in 2002. Provision had been made for 2001-02 and 2002-03. This funding has been extended to the outyears.

*Question: Mr Masters asked the Premier to indicate the cost to the taxpayer of the sustainability unit, the number of FTEs in the unit, and how the issue of greenhouse gas will be addressed under the State Sustainability Strategy.*

*Answer: The budget for the sustainability unit for 2002-03 is \$331,000. The unit has 3 FTEs.*

The State Sustainability Strategy provides the overarching policy framework for the State Greenhouse Strategy, and the State Greenhouse Strategy will form a major plank of the final State Sustainability Strategy.

The State Greenhouse Strategy is being finalised by the WA Greenhouse Taskforce which is chaired by the Hon Francis Logan MLA. To ensure a consistent approach is taken, key staff developing the State Sustainability Strategy (Professor Peter Newman and Mr Andrew Higham) are also members of the WA Greenhouse Taskforce.

*Supplementary Information Request No. A56*

*Question: Mrs Edwardes asked for reasons for higher than normal increase in supplies and services in 2001/02 and the reduction in 2002/03 and a breakdown of both figures.*

*Answer:*

**Supplies and Services** include expenditure items such as:

Professional services;  
Consultancy;  
Legal advice;  
Advertising;  
Audit fees;  
Insurance;  
Leasing costs of Motor Vehicles;  
Security;  
Sitting Fees;  
Stationary cost;  
Building and equipment maintenance costs; and  
General Consumables.

It has not been possible to provide a complete breakdown, however the estimated actual in 2001/02 is higher than normal as it includes the following one off expenditure:

Native Title – \$1.7 million;  
King Edward Memorial Hospital Inquiry - \$1.810 million;  
International Year of the Volunteer - \$170,000;  
Machinery of Government - \$94,000;  
Gordon Inquiry - \$611,000; and  
Legal fees for the former Premier - \$75,000.

In addition, the 2001/02 figure is based on complete expenditure of the Department's budget. This was expected to be the case when figures were prepared in November 2001. However, since that time it has become apparent that there will be some carryover to 2002/03. This will be reflected in the Department's audited financial statements in the Annual Report.

*Supplementary Information Request No. A57*

*Question: Mr Masters asked the Premier how many invitations to functions he has received from local multicultural groups and how many he has sent representatives to.*

*Answer:* This information is not readily available. Provision of this information would require considerable research which would divert staff away from their normal duties and I am not prepared to allocate the State's resources to provide a response. If the Member has a specific inquiry I will endeavour to provide a reply. Representatives have been sent to 77 multicultural functions.
