GOVERNMENT DEPARTMENTS AND AGENCIES, LEVEL 9 POSITIONS

227. Hon C L Edwardes to the Minister for Education; Sport and Recreation; Indigenous Affairs

As at 1 May 2001, for departments, agencies and statutory authorities under the control of the Minister, that are not Senior Executive Service Organisations (as defined by the Public Sector Management Act 1994), will the Minister advise -

 - (x) does the substantive occupant have right of return to the public sector; and
 - (xi) where the position is vacant, the name of the officer acting in that position?
