- (a) how many cards were issued to staff;
- (b) what expenditure and transaction limits applied to the use of those cards;
- (c) the total dollar value of transactions made via those cards;
- (d) the total number of transactions made via those cards; and
- (e) a breakdown of the categories of goods and services purchased via those cards?

Hon Alannah MacTiernan replied:

(a) This information is controlled by NAB and data for the 2019–20 financial year has been purged. To respond to the Member's question, data based on current card numbers for the financial year 2020–21 is provided below, noting that there have been no significant changes in activity between the financial years.
