The implementation strategy, which was released in June 2002, was developed to provide a framework for how the 126 actions would be carried out by the state government agencies and other involved organisations. The committee has most recently contributed to the development of the progress report 2006–09 and the compilation of progress report 2009–10. In compiling these reports, the committee has considered and provided advice regarding a broad range of issues, including air monitoring and research, bushfire prevention and other burning, community education information, domestic activities, health research, industrial emissions, land use and transport planning, and transport emissions.
