ATTADALE PRIMARY SCHOOL, AIRCONDITIONING

1293. Hon. C.L. Edwardes to the Minister for Education

I refer to the answer to question on notice No. 560 concerning air conditioning ducting at Attadale Primary School and ask -

- (a) will the Minister confirm that no other school has the same type of flexible air conditioning duct installed as has been replaced at Attadale Primary School;
- (b) have any other schools ever had the same type of flexible air conditioning duct installed and replaced as at Attadale Primary School;
- (c) when were these installations replaced;
- (d) what type and brand of product was used as a replacement;
- (e) what brand and type of flexible air conditioning duct has been installed at South Perth, Leeming and Belmont Primary Schools;
- (f) what dates were the installations of the air conditioning systems on the above schools carried out;
- (g) who were the contractors who supplied and installed the air conditioning systems at the above schools;
- (h) does the flexible air conditioning duct installed at these schools comply with the requirements of CAMS and/or any other required specifications;
- (i) what documentation was submitted to substantiate compliance with these specifications;
- (i) will the Minister provide copies of this documentation;
- (k) were any of these installations subject to inspections carried out by Government representatives to ensure the correct products were installed;
- (1) who carried out these inspections and what are the qualifications of these inspectors;
- (m) what were the dates of these inspections; and
- (n) at what stage of the installation were the inspections carried out?

Mr CARPENTER replied:

- (a)-(d) Detailed records are not available regarding the various types of air-cooling ducts installed at schools. Many air-cooling installations are undertaken as school projects or funded by Parent and Citizens' Associations.
- (e) South Perth Primary School–The Parents and Citizens' Association arranged for the installation of air-cooling in several classrooms in about 1998/1999.

Supaflex C5M1.

Leeming Primary School-Uniflex 'unilock FR1'.

Belmont Primary School-Uniflex 'unilock FR1' and Dynaflex M6P.

(f) South Perth Primary School–1998/1999.

Leeming Primary School-February 1997.

Belmont Primary School-October 1997, February 1998, January 1999.

- (g) South Perth Primary School–Needham Airconditioning.
 - Leeming Primary School-Temp-Rite Airconditioning Pty Ltd.
 - Belmont Primary School-Temp-Rite Airconditioning Pty Ltd and Project Airconditioning Pty Ltd.
- (h) Yes. The flexible ducting complies with appropriate specifications.
- (i) No documentation was submitted to substantiate compliance with these specifications. However, the relevant documentation has been submitted previously when these contractors were undertaking similar work.

- (j) Yes. Certificates of tests for compliance with standards for flexible ducting can be made available.
