STATUTORY BOARDS AND AUTHORITIES, REVIEW

71. Mrs C.L. Edwardes to the Attorney General

I refer to the review of statutory boards and authorities being undertaken by the State Government and ask -

- (a) is the Attorney General going to establish an appeals tribunal that will deal with matters currently dealt with by statutory boards and authorities eg the builders registration board;
- (b) if so, what are the Attorney General's recommendations relating to the proposal;
- (c) which statutory authorities will be affected by the proposal;
- (d) have these statutory authorities been consulted on the changes and are they in agreement with the changes;
- (e) will the Attorney General table correspondence between his office and the statutory authorities regarding this issue;
- (f) in line with the Government's commitment to openness, has or will public opinion be sought for the proposed changes;
- (g) what will be the funding for the proposed tribunal;
- (h) will the tribunal have original jurisdiction to deal with complaints; and
 - (i) will the tribunal have an appellant jurisdiction?

Mr J.A. McGINTY replied:

- (a) Yes.
- (b) Cabinet has endorsed in principle most of the recommendations contained within the Western Australian Civil and Administrative Review Tribunal Taskforce Report, which sets out a model for a State Administrative Tribunal. The Report has been released for public feedback.
