

GOVERNMENT DEPARTMENTS AND AGENCIES, SENIOR EXECUTIVE SERVICE POSITIONS

204. Hon C L Edwardes to the Minister for State Development; Tourism; Small Business; Goldfields, Esperance

As at 1 May 2001, for departments, agencies and statutory authorities under the control of the Minister, that are Senior Executive Service Organisations (as defined by the Public Sector Management Act 1994), will the Minister provide -

- (a) the number of Senior Executive Service positions other than Chief Executive Officer positions;
- (b) for each of these positions -
  - (i) the title of the position;
  - (ii) the name of the department, agency or statutory authority;
  - (iii) the annual salary for the position;
  - (iv) the classification of the position;
