# CENTRE FOR MENTAL HEALTH SERVICES RESEARCH, FUNDING

### 1516. Dr J.M. Woollard to the Minister for Health

With regard to the importance of mental health as a priority area for Western Australia I ask -

- is the Minister aware that the funding for the Centre for Mental Health Services Research (the Centre) was cut as from 30 June 2003;
- (b) is the Minister aware of the performance of the Centre and the unique contribution it has made to Western Australia;
- (c) is the Minister aware of the recent report of the Centre for Mental Health Services Research that outlines the achievements of the Centre as follows -
  - (i) completing applied strategic research of vital importance to Western Australia on the effectiveness of mental health services to people who suffer from serious disablement due to a serious and persistent mental illness;
  - (ii) demonstrating a high level of productivity in dissemination of its research in publications, professional presentations, technical reports and consultation with the community; and
  - (iii) demonstrating effective, efficient and accountable governance and management as evidenced by separate reviews conducted by KPMG and the Corporate Governance and Audit Services, Department of Health WA;
- (d) was a formal review of the Centre for Mental Health Services Research undertaken by the Department of Health;
- (e) if a formal review was undertaken who conducted the review and who were the members of the review panel;
- (f) did the Centre for Mental Health Services Research participate in the review;
- (g) if so, what was the nature of the Centre's participation;
- (h) if a formal review was undertaken what were the recommendations;
- (i) will the Minister table a copy of the report of the review and its recommendations;
- (j) if a formal review was not conducted, why not;
- (k) where there any other reviews conducted that informed the decision of the Minister;
- (l) if so, what were these and who conducted them and what were the recommendations;
- (m) will the Minister table copies of these reviews;
- (n) did the Centre for Mental Health Services Research participate in these other reviews;
- (o) what are the plans to provide for continuity for the important ongoing research the Centre conducts for Western Australia:
- (p) who will be providing for the continuity of the important ongoing research program established and conducted by the Centre; and
- (q) how long will it take the new provider of the research to develop the level of outputs currently provided by the Centre for Mental Health Services Research?

## Mr R.C. KUCERA replied:

- (a) The relationship between the Centre for Mental Health Services and Department of Health was a contractual one for a period of five years. The Department of Health did not renew the contract as the priorities for spending the funds have shifted
- (b) Yes
