- This figure does not include staffing profile for Joondalup as the Government purchases psychiatric and other medical services on an output basis, and not on the basis of numbers of doctors.

The South West Mental Health Service management has advised that as a result of staff movement, they have insufficient psychiatrist time available for the service and cannot currently guarantee that a medical psychiatric staff member is available when needed to authorise the involuntary status of a patient as defined by the Mental Health Act 1996.
- 4. The South West Mental Health Service has advised that the service commenced a recruitment program last year as a matter of priority. Admissions to the unit will continue to be affected until the Health Service can guarantee psychiatric coverage in order to protect the health and well-being of patients.
