831. Ms J.J. SHAW to the Minister for Transport:

Before I begin today, I acknowledge the presence in the public gallery of the student leaders and principal of Ann Hamersley Primary School from my electorate. I welcome them and hope they have had a lovely day!

I refer to the new Swan Valley hop-on, hop-off bus service the minister launched yesterday. Can the minister outline to the house how the McGowan Labor government is working with local small business operators, such as Adams Charters, to drive tourism throughout the Swan Valley and reverse the eight and a half years of neglect of this region by the previous Liberal–National government?

Dr M.D. Nahan: Did it go to tender?

In opposition we committed to promoting the Swan Valley, and the now Minister for Tourism has been out there promoting what we can do in the valley. Of course, what have we heard from the opposition?
