I refer to the debate on the Planning and Development Amendment Bill during Committee of the Whole, *Hansard* page 3872, in which we were given the response that the development assessment panels had determined that in 2019, 26 projects in regional areas would meet the threshold of \$5 million to be considered a significant development.

 - (a) a brief description;
 - (b) the location; and
 - (c) the estimated cost and value?
