1259. Mr J.B. D'ORAZIO to the Minister for Consumer and Employment Protection:

Will the minister provide the House with information about the property investment seminar that is being run by the Department of Consumer and Employment Protection?

Mr J.C. KOBELKE replied:

I thank the member for the question.

I have previously alerted the House to concerns about people who promote investment seminars, particularly those that relate to real estate. Such people often make money by charging large fees of which people are not advised up front or, alternatively, they may try to sell properties on behalf of people who are associated with the running of the investment seminars. We have sought to have the Commonwealth Government regulate - it clearly has the power in this area - but it has been loath to do so. The Department of Consumer and Employment Protection advertised a seminar that will be conducted tomorrow night. A range of people will provide unbiased opinions to assist people, including representatives from the Australian Securities and Investment Commission, the Australian Competition and Consumer Commission, Curtin University of Technology, the Valuer General's Office, the Real Estate and Business Agents Supervisory Board and the Finance Brokers Supervisory Board -

Mr J.C. KOBELKE: I did not catch the Leader of the Opposition's interjection.
