Commencement date was 29 March 2006 and the estimated duration of this group is approximately two years. In 2006-07 no sitting fees were paid. Expected cost annually is approximately \$1200 per year. An expected total committee cost is approximately \$2400.

Gull Rock Community Working Group - Inaugural/Interim Chairman, Dr John Bailey, Chairman, Conservation Commission of Western Australia. Commencement date was 28 March 2006 and the duration of this group is ongoing. In 2006-07 no sitting fees were paid. Expected cost annually is approximately \$800 per year.

Mt Martin Botanic Park Community Working Group - Inaugural/Interim Chairman, Dr John Bailey, Chairman, Conservation Commission of Western Australia. Commencement date was 29 March 2006 and the duration of this group is ongoing. In 2006-07 no sitting fees were paid. Expected cost annually is approximately \$600 per year.
