DISABILITY SERVICES COMMISSION

- (a) 3157 Grants were made in 2002/2003.
- (b) The records kept show the values of the grants to be as follows:

The 3,157 grants amounted to \$14,469,569.

- (c) Of the total of \$14,469,569, grants amounting to \$12,346,500 (or 85.3% of the total amount) have been acquitted at 16 September 2003.
- (d) The acquittal for the balance is due later on in the financial year, in accordance with the conditions of the grants.
- (e) The balance of \$2,123,069 will be acquitted in accordance with the conditions of the grants, as follows:  
\$476,974 by 31 October 2003  
\$868,899 by 31 December 2003.  
\$777,196 by 31 October 2004.

Where an acquittal is outstanding, it is not possible to say when the acquittal will be provided. ArtsWA reminds recipients by letter of acquittals due. Where the recipient has not provided the information after two letters have been sent, the recipient is ineligible for further funding until the outstanding acquittal is provided.
