

WORKING PARTIES, TERMS OF REFERENCE, BUDGETS, MEMBERSHIP AND REPORTS

1562. Mr Graham to the Minister for Community Development, Women's Interests, Seniors and Youth; Disability Services; Culture and the Arts

Since 10 Feb 2001 -

- (b) TERMS OF REFERENCE: REVIEW STEERING COMMITTEE
 1. To develop and agree a minimum framework for consultation for the review. This framework will apply to the three working groups.
 2. In as far as it is possible, to co-ordinate the consultation processes for the three working groups.
 3. To oversee the three working groups, and receive their reports.
 4. To compile a final report to the Minister, ensuring that the recommendations for the three areas under review are consistent.
 5. To brief the field.
 6. To co-ordinate the review of the Disability Services Act 1993 in line with outcomes from the Machinery of Government review.
 7. To review Part 1 (Preliminary – sections 1 – 5) of the Disability Services Act 1993.
 8. To determine how governance issues, reporting relationships and advisory mechanisms can best be addressed (consistent with Machinery of Government outcomes) while optimising opportunities for input from consumers.
 9. To ensure that the existing opportunities in the current legislation for the disability community's involvement in the directions of the Disability Services Commission are strengthened.

Develop a compact/agreement that will provide a framework for effective cooperation between the Western Australian Government and the voluntary sector. It will support the value of volunteers and encourage volunteering in Western Australia now and into the future.

In developing the compact/agreement, the Reference Group will:

1. Examine other existing compacts/agreements between governments and voluntary sectors in Australia and overseas to identify key success factors that may be suitable for Western Australia.
2. Identify appropriate elements/issues/key stakeholder input for inclusion in the compact/agreement.
3. Develop a compact/agreement, including the key issues to be addressed. Present this to the Minister for Volunteering.
4. Disseminate for public comment.
5. Present the final compact/agreement to the Minister for Volunteering for endorsement before December 2002.

The terms of reference for the Carers Act working party are:

develop a broad policy framework to underpin government's response and commitment to carers;

review existing State legislation and how it impacts upon carers;

review national and international legislation that impacts upon carers;

identify and recommend the scope of the proposed Carers Act; and

provide drafting instructions to Parliamentary Counsel and oversee development of a draft bill.
