## Division 45: Zoological Gardens Board -

Question: Mrs Edwardes asked whether the minister could provide details of which species will be removed from the Zoo under the animal collection plan.

Answer: In 2000/01 a number of bird species were removed from the Zoo as a result of the closure of Wings of the Wild and ongoing trimming of the bird collection. During this period there has also been a concerted effort by ARAZPA zoos to eliminate species held in small numbers from the joint collection due to demographic instability. As part of this exercise some species have been reorganised into different management units which has affected the recognition of subspecies in some cases. The impact of this has been to reduce the apparent number of species in the collection (for example Sugar Gliders). Whilst every effort is made to transact surplus animals as quickly as possible, adequate homes cannot always be found. A case in point are the Syrian bears which have been on the Zoo's surplus list for a number of years. We plan to delete this species from the collection however no suitable recipients have been found. The Zoo also holds as a matter of course a number of aged animals that are the last of their species in the Zoo. It is impossible to predict with accuracy when these animals will die. Therefore, the estimated figures for the planned reduction is based on a combination of planned surplus animals and estimates of aged animals dying.
