Dear Ms/Watson

Thank you for your letter of 12 July 2012 regarding your request for clarification on staff parking fees and the four hour rule reports. I apologise for the extended delay in responding.

As you would be aware, the parking fees at metropolitan hospitals were resolved through WA Parliament and therefore I have tailored the responses to your query below.

Staff Parking Fees

Specifically, you have asked for a schedule of all parking fees which outlines:-

- the 2011/2012 parking fee;
- the proposed 2012/2013 parking fees; and
- the extent to which the fee represents cost recovery, expressed as a percentage.

In respect to your request for a schedule of fees I attach the table entitled "*Current and Proposed Future Staff Carparking Fees at Metropolitan Hospitals*" (Attachment 1). This table sets out the current fee structure for staff at the metropolitan hospitals, classified into either Category A, B or C sites. The fees at January 2012 as outlined in the table reflect the parking fees for 2011/2012 as requested.

As the issue of fees was resolved, Attachment 1 is included in place of your request for the proposed 2012/2013 parking fees. Of note, parking fee increases are being phased in over a longer period to assist staff. Staff parking fees will rise to \$7.50 per day by July 2017, not July 2014 as originally planned. The next increase will be to \$4.80 in July 2013.

Additionally, Fremantle Hospital has been recategorised as a Category B site and Osborne Park Hospital as a Category C effective from Tuesday, 11 September 2012. Parking fees at Category B sites will increase annually in line with the Consumer Price Index (CPI). Parking at Category C sites remains free of charge.

In relation to the extent to which the fees represent cost recovery, expressed as a percentage, I can inform you that that figure averaged 87.12 percent in 2011/12.

In respect to the Department's response to Supplementary Information No C19 requesting supplementary information, please see attached Four Hour Rule reports for the last 12 months in hard copy (Attachment 2) together with a soft copy on disc.

I trust this information is of assistance and satisfies the Committee's request for clarification and further information.
