| Thursday 21 November 2002 | Meeting of Senior Officers convened by DPC regarding service provision to SVNC |
| Friday 29 November 2002 | Interagency meeting convened by DIA Midland to progress service provision to SVNC. Officer level interagency group established. |
| Monday 2 December 2002 | <i>Approach to SVNC to meet – SVNC advised not until late January 2003 – unacceptable to Government</i> |
| Wednesday 4 December 2002 | <i>Audit inspection</i> |
| Friday 6 December 2002 | Interagency working group meeting (DIA Midland) – information update and planning |
| Wednesday 18 December 2002 | Meeting at SVNC between Senior Officers, Robert Bropho and a few community residents. Purpose: To establish contact and discuss service provision. Outcome: Agreed to further meeting but agreed outcomes were later disputed by SVNC. |
| Thursday 27 February 2003 | Interagency working group meeting (DIA Midland) – information update and planning
Outcome: Decision to proceed with SVNC planning and include other communities. |
| Wednesday 19 March 2003 | Interagency working group meeting (DIA Midland)
Outcome: Two Officers to visit SVNC to try to progress workshop idea |
| Friday 21 March 2003 | Meeting of Senior Officers convened by DIA for information update. |
| Wednesday 26 March 2003 | Visit to SVNC by two Officers (DIA & DCD) of the interagency working group. Robert Bropho refused to speak with them and directed them to Margaret Jefferies.
Outcome: Officers advised SVNC would not participate in any on site meetings. |

The Interagency working group continued to operate with an emphasis on the other three urban communities. **The group has met frequently (not all members in attendance) between the meeting listed above in attempts to progress services to the residents of SVNC.**
