LEGISLATIVE COUNCIL STANDING COMMITTEE ON ESTIMATES AND FINANCIAL OPERATIONS

THE LEGISLATIVE COUNCIL STANDING COMMITTEE ON ESTIMATES AND FINANCIAL OPERATIONS INQUIRING INTO BALGA WORKS: NON-PARTICIPATION IN EDUCATION, TRAINING AND/OR EMPLOYMENT BY 16 AND 17 YEAR OLDS.

BACKGROUND

There are two significant groups who are considered most at risk in the sixteen and seventeen year old age groups. This data was taken at the Department's August 2008 Census. They are:

- approximately 500 Refusal to engage; and
- approximately 1 400 Un-lodged or in transition between Notices of Arrangements.

CURRENT SITUATION

The 1 900 often display multiple risk factors and barriers to engagement in education, training and employment. These include:

- family dysfunction;
- homelessness;
- history of sexual, physical and emotional abuse;
- intergenerational poverty, unemployment and little value placed on education in the family;
- · dependency on and abuse of alcohol and other drugs;
- mental illness:
- crime, justice involvement and periods of detention;
- isolation and transiency;
- poor literacy and numeracy;
- alienation and disaffection from school and the wider community; and
- a significant group of Aboriginal boys in remote and metropolitan communities.

While these most at risk young people are spread throughout the State there is a tendency for them to cluster. Swan Education District has high concentrations in certain suburbs such as Balga, Girrawheen, Mirrabooka and Beechboro.

Below is a snapshot of highly at risk 16 and 17 year olds being provided intensive, individualised support by Participation Coordinators, by education district - March 2009.
