### Answer:

No. The deficit shown for 2013-14 will be covered by accumulated surplus funds (Cash at Bank).

The reduction in the total appropriation is mainly attributable to the cessation of funding agreements and finalisation of one off funding schemes including:

- \$1.25 mil Stolen Wages Reparation Scheme completed; and
- \$2.2 mil COAG Remote Service Delivery Agreement ceases.

- a) The purpose of the Aboriginal Community Emergency Response Fund (ACERF) is as follows:
  - ACERF is an emergency response fund that provides the Aboriginal Affairs Coordinating Committee (AACC) with the ability to approve immediate action to deal with emerging crises in regional Aboriginal communities and the capacity to intervene in a more effective manner to pursue time critical interventions and emergency responses which urgently need to be met by Government.
  - ACERF is a \$10 million dollar fund that will be consumed progressive over the forward estimates period 2011 - 2015 and beyond, on a needs basis. ACERF will enable flexible and timely responses to crisis situations, such as a public health risk or community safety risk, for Aboriginal people living in remote, regional and town based communities.
  - ACERF will allow the AACC to act at short notice whilst allowing responsible agencies to later apportion expenditure from existing programs and appropriations where applicable.
- b) The nature of the fund does not enable the forward prediction of expenditure in a specific region of Western Australia.

What was the purpose of the Kimberley Interpretive Service and can the Department fulfill its goals/programs without this service?

### Answer:

The purpose of the Kimberley Interpreting Services (KIS) is to:

- provide a central booking service for registered and accredited Aboriginal language interpreters;
- match clients with interpreters according to Indigenous cultural protocols, client needs, and interpreter specialization;
- provision of training courses for new interpreters in arrangement with Central Institute of Technology Perth for the delivery of the Diploma of Interpreting;
- development of strategies to educate Aboriginal communities about the proper role of interpreters as communicators rather than decision makers;
- provide interpreter services for Aboriginal individuals and families to assist in accessing services delivered by Government and ensure an individual understands of obligations and options (particularly with regards to justice and health services); and
- provide interpreter services across the four priority locations in relation to the National Partnership Agreement for Remote Service Delivery (RSD).

The Department of Aboriginal Affairs (DAA) is able to fulfill its goals and programs through:

- the use of community people who are bilingual and are able to interpret the local Aboriginal language on an as needs basis;
- the use of language (oral and written) that will enable communication between DAA and its clients who speak little English or English is their second language; and
- engagement of suitable qualified interpreters (fee for service) where there is a need for a formal interpreting services.

- d) The Department of Aboriginal Affairs (DAA) is working to provide the Minister for Aboriginal Affair (the Minister) with a Cabinet Submission in 2013 or early 2014.
- e) The proposed technical amendments will:
  - allow for much greater protection of sites through higher penalties, the extension of time to prosecute from the time of the offence to accommodate the remoteness and inaccessibility of the State and the ability for the Courts to issue remediation orders to repair or restore damage to sites;
  - improve the quality of information on the Register of Aboriginal places and objects (the Register) through being able to prescribe a more robust, transparent and accountable assessment process;
  - make it clear that processes for entering and removing information on the Register, the information on the Register and the prohibition or restriction of disclosure of some or all information in the Register will be prescribed in regulations;
  - improve evaluation of the importance and significance of places and objects in accordance with sections 5 and 6 by proposed additional prescribed criteria;

- ensure that Traditional Owners and others who know the relevant Aboriginal traditions will be consulted as the source of information about the importance and significance of sites;
- improve the accuracy of site location information on the Register;
- allow the DAA to recover costs for services provided which will enable departmental resources to be applied flexibly in response to demand for services from Aboriginal communities; and
- ensure that all persons or bodies who use or manage land can clarify their obligations to protect Aboriginal heritage under the *Aboriginal Heritage Act 1972* (AH Act).
- f) The proposed amendments provide for the administrative procedures associated with the Register of Places and Objects and section 18 consents to be prescribed in the Aboriginal Heritage Regulations 1974 (AH Regulations). New administrative processes will also include new forms and delegations.
- g) The timeframe will be informed by stakeholder needs.
