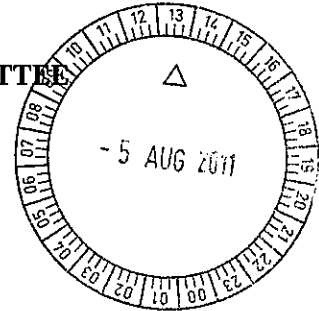

Question No C1: Hon Linda Savage asked "Could I please ask, as a supplementary question, to be provided with a list of those services that you could identify for the zero to four-year-old age group—coming from the mental health budget?"

Answer:

All community CAMHS are funded to provide services for children aged 0-17 years. Community CAMHS are based at the following sites: Armadale, Bentley, Fremantle, Peel, Rockingham, Clarkson, Hillarys, Warwick, Swan (Midland) and Shenton Park.

Whilst there are no specific Infant Mental Health Services, both Family Pathways and the Paediatric Consultation Liaison service at Princess Margaret Hospital treat a number of children under the age of four years.

The Injury Control Council of Western Australia (ICCWA) is the host organisation for this position. This person will be travelling throughout the South West, including the locations of Bunbury, Busselton, Blackwood, Leeuwin, Leschenault, Warren and Wellington to identify up to seven Community Coordinators for the development of up to seven Community Action Plans. The Ministerial Council on Suicide Prevention (MCSP) has appointed 6 new members and renewed 3 existing members.

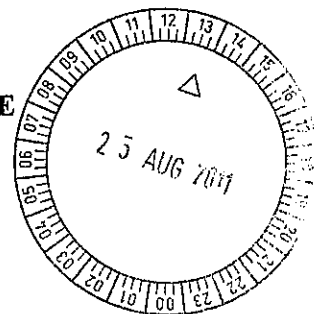

Question No C7: Hon LJILJANNA RAVLICH asks in relation to security and safety at Rockingham General Hospital "this has not been able to be achieved since 20 November last year. How long does it take to heighten a fence and to get a swipe mechanism installed? Why is it taking so long?"

Answer:

The original fence design was approved by Dept. of Health as part of the approval of the initial MHU building. After completion of the unit the Dept of Health advised that the fence for the secure courtyard was not acceptable in form and colour. On instruction from the Dept of Health the upper section of the fence was removed. BMW has been working with the original design consultants to identify a suitable fence that would be supported by the Dept. of Health. Funding for this work had not been identified by the Dept. of Health at that stage. The initial redesign was abandoned in December 2010 as not meeting requirement and need to manage funding for this re-work. Approval for an amended design was received by BMW on the 21 June 2011. (NB: Health only received drawings on the 16th June 2011 for sign off).

The work was all post completion therefore on award of such works to contractors and subcontractors requires far more lead time to implement. This was also applicable in the case of design consultants who are effectively on other programs of work to develop design schemes in short timeframes after project completion. Funding issues have also hampered getting approvals to proceed in place.

Construction/erection of the fence has now been completed with painting to be completed as weather conditions permit.

On completion of the building Dept of Health, advised that an additional 13 Swipe Card Readers were required and further updated to 15 Swipe Card Readers. Approval to proceed was granted 18 May 2011 on identification of funding. They stated that, because swipe card work was retrospective, they had to choose a card reader type that was not the most typical and therefore harder to source, thus causing delay. BMW advise that this should be completed by 25th August 2011.

This was also applicable in the case of design consultants who are effectively on other programs of work to develop design schemes in short timeframes after project completion. Funding issues have also hampered getting approvals to proceed in place.

The additional \$300,000 funding to Youth Focus will assist them in managing their waitlist and increase their ability to provide services to 180 young people in the Perth metropolitan area.

Question No C9: Hon Ken Travers asked: Because it relates to the creation of the department I do not think it is unreasonable for us to ask you to demonstrate to us that there has not been an increase in SES positions as a result of the creation of this agency. The only way you can do that is to give us the figures of the Department of Health prior to the establishment of the Mental Health Commission and the figures for the Department of Health and the Mental Health Commission today.

Answer:

Prior to the establishment of the Mental Health Commission, the Mental Health Division of the Department of Health had two senior executive positions, Executive Director; and Director Performance and Operations. Currently, as at 22 June 2011, the Mental Health Commission has two permanent senior executive positions, being Commissioner Mental Health and Director Performance and Reporting; and four temporary senior executive positions being Director Policy, Strategy and Planning; Director Purchasing and Development; Director Organisational Reform and Director Corporate Services and Governance.

Information on other Senior Executive Mental Health positions within the Department of Health will need to be directed to the Department of Health.

Question C10: Hon KEN TRAVERS asked "My final question is: are any mental health patients ever held in emergency departments awaiting bed placements for more than 24 hours?"

Answer: Yes, people with a mental illness can be in emergency departments (ED) for more than 24 hours. People with a serious mental illness are admitted via the ED to mental health wards at the hospital they attend for specialist care, if the hospital has such wards. Others may need to be transferred to mental health wards at other sites.

Those who remain in the Emergency Department are there to receive treatment appropriate to their condition.
