2017-18 Annual Reports questions prior to hearings**

Lotteries Commission

The Committee asked:

1. How frequently do you review your

(a) key performance indicators

Key Performance Indicators (KPIs) are reviewed on an ad hoc basis in response to changing business conditions and requirements.

(b) key performance indicator targets?

Targets are reviewed constantly in response to changing market and business conditions.

2. When were your key performance indicators last reviewed?

The last formal review of KPIs took place between August-September 2017 as part of developing the 2018–2023 Strategic Plan.

3. Can you provide any documentation from your last review of your key performance indicators?

KPIs listed in the Annual Report have been consistent since 2006 and reflect industry practice. Lotterywest assesses current and prospective KPIs across a range of criteria (effectiveness, measurability, target setting, feasibility, coverage etc.). The evaluation itself was done internally and is commercially sensitive for Lotterywest.

4. Can you list any new key performance indicators for this year?

No new KPIs in the Annual Report.

5. In relation to credit and debit card payments

(a) Do you allow a person to pay for goods and services with credit or debit card

Lotterywest does not allow online products to be purchased using credit or debit cards directly. Customers may purchase Lotterywest online products from their e-wallet and may use various funding sources to transfer funds into their e-wallet. Lotterywest retail agents accept payment forms suitable to their business, including credit or debit cards.

(b) If so, when a person pays a fee or fine by credit or debit card

(i) What surcharge do you apply to process that card payment

Lotterywest does not apply a surcharge. Lotterywest also meets the cost of any BPOINT transactions fees, typically around \$0.11 per transaction.

Hon Tjorn Sibma MLC asked:

1. Regarding the Chair's executive summary on pages 6 and 7, can you elaborate on the reasons for the improved annual sales figure of 3.4%?

There are three key reasons for the better than expected end of financial year sales performance:

- A more favourable set of jackpots in 2017-18 compared to the previous year;
- Strong sales performance from retail-only products (Scratch'N'Win); and,
- Powerball game changes in April 2018 generating strong end-of-year demand.

2. Regarding the Chair's executive summary on page 6, what were the "...challenges of an increasingly competitive and complex business environment" encountered by Lotterywest in the last twelve months and how are these factors likely to change in the next twelve months?

Major challenges faced by Lotterywest include: adverse economic conditions reducing discretionary spend; increased competition from online competitors; changing consumer behaviour; increased operating expenses for retailers.

Over the next twelve months, some factors have an improved outlook. This includes: WA's economic recovery and improved confidence; banning of synthetic lotteries; and improved stakeholder management and distribution approaches to improve business sustainability for retailers.

3. I refer to the following quote from the Chair's statement on page 7, "The Premier has been a staunch advocate of our returns to community, standing firm against 'synthetic' lotteries which offer betting opportunities on the outcome of lottery draws and divert revenue raised to international based companies"; and I ask:

- (a) Have other parliamentarians aside from the Premier also been staunch advocates for Lotterywest's "returns to the community";

The Premier is the Minister responsible for Lotterywest and page 7 relates to his role as responsible Minister. Lotterywest receives broad support from across the community and parliamentary representatives.

- (b) What is the precise nature of the threat posed to Lotterywest by 'synthetic' lotteries and how is this different to other digital gaming or wagering applications;

Synthetic lotteries, such as Lottoland, offer no benefit to the WA community by way of

returns in community grants and returns to Government. As a majority of Lotterywest customers play lottery games as their only form of gambling, market share absorbed by synthetic lotteries such as Lottoland is likely to have a greater impact on Lotterywest's return to community than other digital or wagering applications.

- (c) In dollar terms, how much revenue was forgone by Lotterywest and/or market share lost by Lotterywest in 2016-17 and 2017-18, as a direct consequence of the operation of 'synthetic' lotteries; and

Internationally based companies offering synthetic lotteries do not openly report on sales. As of June 2018, an estimated 4% of Western Australians had made a purchase with Lottoland in the previous 12 months.

- (d) In relation to (c) above, how were these figures calculated?

Lotterywest commissioned research to measure market share and the participation of Western Australia residents with identified direct and indirect competitors.

4. Regarding the Board's "...decision to support the retail shopfit costs" as reported on page 6 of the Chair's executive summary:

- (a) When did the Board make this decision;

27 July 2017.

- (b) Was there a business case upon which this decision was made;

An "Retail Transformation Project Shopfit Review" provided a briefing to the Board to inform the decision.

- (c) Did the decision to support retail shopfit costs represent a change of policy for the Board; and

Yes.

- (d) If yes to (c) above, what was the reason for the change?

Feedback and concerns were raised by Lotterywest retailers, stakeholders and Government about the costs associated with the new Lotterywest shopfit.

5. Which of the market research firms identified on page 44 undertook the market research task identified at page 8 that surveyed retailers and captured their "...views and insights":

ACIL Allen Consulting and Faster Horses

- (a) Further to the above, what were the terms of reference for this market research work;

The primary objectives of the Retail Network survey were to understand the challenges faced by Lotterywest Retailers and identify limitations to increasing the sales of lottery products. The primary objective of the workshops and interviews was to explore what opportunities the Retailers see for resolving the challenges identified, into the future.

- (b) When was the market research commissioned and conducted;

ACIL Allen Consulting was commissioned in January 2018 to undertake a survey of the Retail Network that was completed in February 2018. Faster Horses was commissioned in February 2018 to undertake workshops and interviews with Retailers

in March 2018.

- (c) What were the "views and insights" of retailers captured by the report; and

Topics covered included: the partnership between Lotterywest and its retailers; new lottery products and services; Lotterywest's strategy for growth across different channels; store requirements including the shopfit, and ways to improve the service provided to retailers by Lotterywest.

- (d) What specific findings of the report have been implemented/will be implemented/not considered/rejected by Lotterywest?

For example, Lotterywest has increased face-to-face engagement with the retailers and increased store visits, provided new pathways for contact with Lotterywest, and conducted a number of internal process reviews to ensure our work with retailers is efficient. Further work contributing to Lotterywest's approach to distribution and retailer support is continuing and is expected to be finalised in 2018-19.

6. Regarding Lotterywest's campaign with Tatts Group and the Australian Lotteries Newsagents Association reported at page 8, I ask:

- (a) Who made this decision on Lotterywest's behalf and for what reason(s);

Recommended by the Lotterywest CEO to support Lotterywest retailers and to work cooperatively with the Australian Lottery Bloc.

- (b) Were any conflicts of interest, or perceptions of conflicts of interest, identified prior to the decision to jointly campaign against 'synthetic' lotteries, and how were these conflicts managed;

No conflicts of interest were reported.

- (c) What Lotterywest resources did participation in this campaign necessitate;

Tatts Group covered costs associated with Bloc members' contribution to the campaign. Lotterywest supported the campaign with co-branding and locally through social media channels, website and via email.

- (d) Did Lotterywest make a financial contribution to this campaign; and, if so, what was the value of this contribution, what was the contribution for, to whom was it paid and when, and who authorised the payment;

No financial contribution was made by Lotterywest.

- (e) Did Lotterywest advise or seek the Minister's permission for participation in this campaign; and

Yes

- (f) Did Lotterywest engage in lobbying either directly or indirectly as a consequence of its participation in this national campaign?

No (lobbying was undertaken via Tatts Australian Lotteries Bloc) and ALNA Australia.

7. Regarding the discussion of the grants program on page 9:

- (a) For what reasons and when did the Board initiate and support planning sessions on

"how to build the effectiveness, outcomes and impact of Lotterywest grants, along with how to measure the impact they have in the community";

On 27 July 2017 the Lotterywest Board agreed to hold a grants strategy workshop by the end of that year. The Board agreed that it was timely to review operations to improve grant-making. The Board's Grants Strategy Workshop was held on 11 December 2017. Key topics included:

- Governance;
- Assessment Process;
- Measurement; and,
- Future Focus.

- (b) Is this an area of focus that the Board of Lotterywest has previously held - if not - why the current attention;

Section 24 of the Lotteries Commission Act 1990 outlines a function of the Commission is to distribute funds "to eligible organisations as the Commission sees fit...". The Board resolved to review Lotterywest's approach to grant-making as part of their appropriate duties.

- (c) Was/is the previous/current grants framework deficient in some respect, and what are the details;

No. The Board's review was motivated by the need to ensure that Lotterywest's grant-making was responsive to best serve the not-for-profit sector and to ensure that grant funds deliver the greatest positive impact for the WA community.

- (d) Who are the stakeholders with whom Lotterywest wishes to align grants delivery;

Lotterywest has recently come together with Healthway under one CEO. Several of Lotterywest grant stakeholders and not for profit organisations are moving to a 'community impact' approach to granting.

- (e) Has Lotterywest consulted with the Minister or ministers concerning these changes, when did these consultations occur, and what was the result of these consultations?

The Premier and his department have been kept updated on the review approach. Communications on the new approach will be rolled out shortly.

8. In relation to the figures provided on page 18 concerning Player channels, I ask:

- (a) Can Lotterywest provide the dollar value of sales made through online and retail channels in 2017-18;

Sales made through online in 2017-18 were \$81,065,617. Sales made through retail outlets in 2017-18 were \$773,498,160.

- (b) How has the proportion and dollar value of sales made through online and retail channels changed in the last five years up to and including 2017-18; and

- (c) What forecasts and/or targets has Lotterywest made about the future composition of sales through these two player channels over the next five years?

Over the next five years Lotterywest expects the online channel to grow from approximately 10% to 15% of total sales, with commensurate adjustments in retail.

Lotterywest projects online sales to continue expanding rapidly as it reaches new customer segments and challenges online competitors. Retail is a mature channel and therefore grows more slowly, however Lotterywest also projects an increase in retail sales over the next five years.

9. On page 19, Lotterywest reports that it distributed \$607,232 of incentives and rewards in 2017-18 to retailers, can Lotterywest advise what this amount represents as a proportion of:

- (a) the sale of lottery products;

11. I refer to product sales data provided on pages 22 and 23, and I ask:

(a) What is the cost of goods sold for each of the nine products sold in 2017-18;

(b) What analysis has been undertaken to explain the relativities in volume of sales for each of the nine products sold in 2017-18;

Assessing performance strictly on a year-on-year basis can be misleading, due to differing compositions of events for the two main jackpot games (OZ Lotto and Powerball), which in turn impact sales for all the products. For this financial year, this was complicated further due to changes to the Powerball game in April 2018.

Rather than assessing relativities, Lotterywest generally seeks to understand how specific sales opportunities are performing against comparable historical benchmarks.

(c) What process did Lotterywest undertake to set prize-pools and jackpots for lotteries draws in 2017-18 and how does this differ from previous years; and

Prize-pools and jackpots for major lottery draw games are determined by the Australian Lottery Bloc and consider potential sales, odds of winning and potential return to the community. There was no change to the process used to determine prize allocation and jackpots in 2017-18.

(d) Noting the retirement of the Soccer Pools product line, what rationale remains for the retention of the 'Super66' and 'Cash 3' products?

Both Super66 and Cash 3 offer Western Australians a way to play a lottery game that is a lower cost compared to major draw games. Combined, Super66 and Cash 3 contributed almost \$15 million in sales in 2017-18.

12. I refer to the information provided on pages 80-92 (inclusive) regarding grants and grants distribution, and I ask:

(a) Can Lotterywest supplement the list of successful grants recipients listed with information about the electorate in which the recipient organisation is based, or for which the program or project funded by the grant will be delivered?

Yes, full program attached.

13. Concerning the grant approval process identified on page 31, I ask:

- (a) How many grant applications were rejected by Lotterywest employees in 2017-18; and

No grant applications were rejected, but 144 applications were withdrawn by the applicant between 2017-18.

- (b) What were the details of these rejected submissions and the reasons given for these rejections?

Reasons for withdrawal included:

- Incomplete application;
- Ineligible organisation;
- Further development required;
- Timing does not align (retrospective); or
- Doesn't align with Lotterywest's approach.

14. Regarding the grants approval process identified on page 31, I ask:

- (a) How many applications for Lotterywest grants in 2017-18 were recommended for approval by staff but were rejected by the CEO or one of the General Managers; and
None.

- (b) If applicable, for what reason(s) did the CEO/General Manager(s) over-rule a staff recommendation(s)?

- (a) From which minister or ministers did Lotterywest seek approval for the provision of grants in 2017-18;

The Premier is the Minister responsible for Lotterywest.

- (b) Regarding (a) above, on which dates were these approvals sought, and when was confirmation of approval (or otherwise) conveyed back to Lotterywest;

Lotterywest provides recommendations on grant approvals to the Premier regularly throughout the year. Dates of the Minister's grant approval decisions in 2017-18 are:

The Premier and his department have been briefed about the review as it progresses.

This occurred in regularly scheduled meetings and meetings with the Department of Premier and Cabinet.

The Strategic Framework will be circulated to stakeholders shortly.

Strategic Business Approach; Lotterywest Investigation of Distribution Opportunities 2018-23

Objective

The objective of this activity is to recommend distribution opportunities that meet customer needs and emerging behaviours and provides for a sustainable business model for Lotterywest in maximising returns to the WA community beneficiaries.

As part of the process, Lotterywest will consider options within its control of managing and/or reducing the impact on existing retailers and traditional business types.

Background and Context

Globally, traditional lotteries are facing significant challenges. Lotterywest's challenges include (but are not limited to):

- Relevance of traditional lottery products, including their current distribution approach, to various market segments;
- Changing demographics and consumer behaviours;
- Digital disruption changing customer shopping habits, including the decline in usage of traditional retail channels and types;
- Increased and diverse competing offers;
- Economic conditions and competing priorities for consumer discretionary spend; and
- Stakeholder priorities and agenda alignment.

As a result of the above challenges and despite Lotterywest continuing to exhibit high lottery sales in comparison to per capita global trends, Lotterywest sales growth continues to soften.

In an effort to respond and reverse this trend and to continue to deliver increased returns to the WA community, a number of initiatives to evolve and grow the business have been progressing, part of which is Lotterywest's approach to its distribution strategy and channel mix which is currently articulated in its Distribution Plan (for terrestrial channel distribution) and its Digital Strategy (for online channel distribution and cross-channel (aka omni-channel) distribution).

In mid-June 2017 work commenced to review Lotterywest's 2015 Distribution Plan and environmental scanning work has also commenced. Lotterywest is also advancing its planning regarding the roll-out of increased digital sales opportunities for its products.

Review Outline

The Review will comprise the following components:

1 Context

- 1.1. Review and document Lotterywest's current distribution channel strategies (including methodology, modelling, performance and validity to date) fit for purpose;

- 1.2. Perform market analysis of recent customer insights and feedback, focusing on preferences and expectations of key target markets;
- 1.3. Undertake an environmental scan showcasing key competitors' and traditional lotteries distribution channel strategies and approach.

2 Issue Identification

- 2.1 Outline the opportunities, strengths, risks and limitations of current and potential distribution channels and mix;
- 2.2 Consult and engage with key stakeholder groups on their view of the future state of the distribution channel mix highlighting areas of alignment and areas of tension.

3 Option Evaluation

- 3.1 Identify and quantify distribution channel mix scenarios responding to current and future trends including consideration of channel migration, cross-channel distribution, and trailing commission services and the applicability and viability of such options.

4 Impact Analysis

- 4.1 Outline and quantify the opportunities, strengths, risks, limitations, gain and loss to Lotterywest, Government, community and current Lotterywest retailers in the various distribution channel mix scenarios.

5 Recommendations

- 5.1 Provide recommendations on distribution channel mix with associated modelling and high-level outline of the implementation approach (design, development, piloting, communications, engagement, timeframes)

Review Process


In order to ensure quality assurance and a level of external reference and rigour it is proposed that an expert panel oversee the development and progress of the review. It is envisaged that the tasks of this Panel would include: review and feedback of this scope document; review of documents and draft reports as they are developed; advice on progress on the work as it progresses; and agreement to the final recommendations.

It is recommended that the following members be appointed to the Review Panel:

- An independent 3rd party consultant with proven experience in business, knowledge of retailing and with standing;
- The Commissioner (or nominated representative) of the Western Australian Small Business Development Corporation;
- A Board member (or nominated representative) from the Lotteries Commission Board; and
- The Chief Executive Officer of Lotterywest.

Time Frame

Following approval of objective and scope of work a detailed plan will be developed with the target of having recommendations and a final report to the Board and Minister by February 2018.
