Thank you for your letter of 31 August 2004 attaching a copy of the Report of the Standing Committee on Uniform Legislation and General Purposes in Relation to Uniform Legislation and Supporting Documentation (Report 19) (August 2004).

I have noted the matters in your letter and the Report and, in particular, the Committee's three recommendations:

Recommendation 1: The Committee recommends that the Government ensure that a Premier's Circular is issued in the form attached as Appendix 7 to this report as soon as possible.

Recommendation 2: The Committee recommends that all government departments and agencies amend their procedural documentation to alert staff to the requirements of the Premier's Circular referred to in Recommendation 1.

Recommendation 3: The Committee recommends that until such time as a Premier's Circular is issued all government departments and agencies amend their procedural documentation to include reference to the matters raised in the draft circular attached as Appendix 7 to this report.

In this context, the Draft Premier's Circular (in appendix 7 - pp 57-60), if adopted, would require, as a matter of policy, for example, that Second Reading Speeches introducing a Bill to implement uniform legislation must refer to the fact that the Bill is pursuant to such uniform legislation and outline the relevant inter-governmental agreement or memorandum pursuant to which the Bill is introduced as well as, for example, providing the above Committee with a copy of minutes of the Ministerial Council Meeting at which is was agreed to introduce the model legislation.
