SPECIAL REPORT OF THE STANDING COMMITTEE ON ESTIMATES AND FINANCIAL OPERATIONS IN RELATION TO A MATTER OF PRIVILEGE

1 MATTERS OF PRIVILEGE RAISED AT COMMITTEE MEETING

- 1.1 On Monday 19 March 2007 a meeting of the Estimates and Financial Operations Committee (**Committee**) was held. Members present at that meeting were Hons Giz Watson (Chair), Ken Travers and Nigel Hallett MLCs. Hons Anthony Fels and Shelley Archer MLCs were apologies.
- 1.2 During the meeting the Chair drew the Committee's attention to:
 - a) a possible breach of parliamentary privilege in relation to alleged disclosures of deliberations of the Committee; and
 - b) a request made by the Corruption and Crime Commission (CCC) for access to committee records, members and staff.

2 ALLEGED DISCLOSURES OF COMMITTEE DELIBERATIONS

Nature of alleged disclosures

- 2.1 The Chair's awareness of this matter resulted from inquiries made of her by the CCC.
- 2.2 At the Committee's meeting the Chair tabled an outline of facts relating to her knowledge of the matter with relevant documents (attached to this report as Appendix 1).
- 2.3 Due to the nature of the inquiries made by the CCC of the Chair it appeared to the Chair that the Committee's deliberations had been disclosed to third parties by a Committee member, or members, without authorisation. Disclosure appears to have been made to the CCC and to other persons.
- 2.4 In addition the Committee notes that matters relating to the Committee's deliberations have been raised in the CCC during its examination of Noel Crichton-Browne and Hon Shelley Archer MLC on 21 February and 28 February 2007 respectively. Relevant portions of the transcripts are extracted and form part of Appendix 1.

Reporting of matter to the House

- 2.5 The Committee notes that:
 - Members must not disclose proceedings (including deliberations), evidence or documents not specifically authorised; and

- any unauthorised breach of this confidentiality may be dealt with by the House as a contempt.
- 2.6 Erskine May comments on the disclosure of a committee's proceedings or evidence as follows:¹

By the ancient custom of Parliament "no act done at any committee should be divulged before the same be reported to the House" ….

The publication or disclosure of proceedings of committees conducted with closed doors or of draft reports of the committees before they have been reported to the House will, however, constitute a breach of privilege or a contempt.

2.7 The Committee also notes Standing Order 422 which provides:

Committee not to entertain charges against a Member

- 422. If any information come before any committee which involves an accusation against any Member, the committee shall direct that the Council be acquainted with the matter of such information, without proceeding further thereupon.
- 2.8 The Committee therefore resolved to report this matter to the House.

3 CCC REQUEST FOR ACCESS TO COMMITTEE RECORDS, MEMBERS AND STAFF

CCC request

- 3.1 On 12 February 2007 the Chair received a letter from the CCC requesting a copy of the agenda and minutes for the Committee meeting of 31 January 2007. The Chair responded by letter dated 13 February 2007. (Letters attached to Appendix 1).
- 3.2 The Committee observes that these documents were prepared as part of the Committee's proceedings, are confidential to the Committee and covered by parliamentary privilege. While the Committee may have power to disclose such material, in view of the purpose for which the material may be used and its relationship with the matter of privilege raised in this report the Committee resolved that it is appropriate that the Committee report this matter to the House for its consideration.

STATEMENT OF FACTS

Matters arising from meetings with the Corruption and Crime Commission

The following matters of fact are presented for consideration by the Estimates and Financial Operation Committee that indicate that a breach of privilege may have occurred with the disclosure of committee's deliberations.

Matter leading up to the CCC inquiry

- At the Estimates and Financial Operation Committee meeting held on 30
 October 2006 Hon Anthony Fels advised the committee that he intended to move a motion that the committee inquire into the Iron Ore Industry.
- The committee asked Hon Anthony Fels to provide members with a brief outline of the various issues and present them at the next meeting scheduled for 13 November 2006.
- On 4 December the committee received a letter from Mr Ian Loftus, Policy
 and Public Affairs Manager from the Association of Mining and Exploration
 Companies (Inc) (AMEC) dated 27 November 2006. Mr Loftus outlined his
 concerns into the Western Australian iron ore policy. The letter indicated
 AMEC had become aware that the Estimates and Financial Operation
 Committee was considering an inquiry into the Western Australian iron ore
 policy.
- Hon Anthony Fels proposed inquiry however was not discussed again until
 31 January 2007. At this meeting the committee received a letter from Hon
 Anthony Fels outlining the proposed terms of reference in relation to the Iron
 Ore Industry in Western Australia. It was resolved to defer the matter.

Approach by the CCC

- On Thursday 8 February Tanya Campbell (investigator) from the Corruption and Crime Commission telephoned seeking a "meeting" with me as the Chairperson of the Estimates and Financial Operations Committee.
- I requested Tanya to place the request for a meeting in writing. Later that day I received the letter requesting a meeting on Monday 12 February 2007 (see Appendix A).
- I contacted the Acting Clerk Mr Malcolm Peacock to seek advice and met with him on several occasions over the next few days.
- I replied to the letter on the 9 February 2007 and stated I would agree to meet on Monday 12 February 2007 subject to the response to certain questions. I further advised the CCC I had requested the Acting Clerk Mr Malcolm Peacock to attend the meeting (see Appendix B).
- I received a response to my letter on the morning of 12 February 2007 (see Appendix C).
- On Monday 12 February 2007, at 9.30am, I and the Acting Clerk meet with Tanya Campbell (investigator) and John Lynch (senior investigator) at my electorate office. From what was disclosed it would seem a member of the Estimates Committee has disclosed to the CCC the fact that another member of the committee had divulged committee information to a third party. The CCC asked if the Hon Anthony Fels had proposed an inquiry into the iron ore policy and referred to a letter from Association of Mining and Exploration Companies (AMEC).

- The CCC asked about a comment made, that could have only been known by a
 Member or staff member, at a closed meeting of the Estimates and Financial
 Operations Committee. It seemed to be known by the CCC that Hon Anthony
 Fels had approached AMEC to discuss the proposed inquiry after that
 Committee meeting.
- On the 12 February 2007, I received a letter from the CCC requesting a copy
 of the agenda and Minutes for the Estimates and Financial Operations
 Committee meeting of 31 January 2007 (see Appendix D).
- I responded to the letter on 13 February 2007 (see Appendix E).

Public Hearing of the CCC

• On 21 February 2007 during the public hearings of the CCC Mr Hall (Counsel assisting) asks a number of question of Mr Crichton-Browne¹ as follows:

"Do you know whether Mr Fels sits on the Estimates Committee?--Thank you, yes, a notice of motion taking a reference in respect to the iron ore industry in Western Australia.

Right. Now, when you say that is something you were suggesting the Estimates Committee might do an inquiry into?---Yes.

And what has Mr Fels - you've made the suggestion to Mr Fels and has
- in that capacity you were acting as a paid consultant for someone?--Yes.

Is that business that you're doing with Mr Burke and Mr Grill?---I'm dealing directly with the company.

Right. Which company is that?---Kazalie.

Have you told Mr Fels that you were acting as a paid consultant in this regard?---Yes, I have.

Do you know whether that outcome has been obtained?---I suspect is hasn't.

When you say you've suggested it, have you done more than suggest it? Have you helped him with possible terms of reference for the inquiry?---Yes, I have.

In fact have you dictated those terms of reference?---Yes.

Has that inquiry been publicly announced?---No.

Do you know what state it has reached?---No I don't. I know it hasn't progressed but I don't know what state - - "

- I note from the CCC transcript of evidence on 28 February 2007² Mr Urquhart (Counsel assisting) stated "third matter is in relation to a proposal parliamentary standing committee requesting an inquiry into the state's iron ore policy. In each instance the hearing will consider whether misconduct by any public officers".
- Later in the transcript of evidence³ I note Mr Urquhart states the following:

"Turning now to the last matter which involves the Standing Committee on Estimates and Financial Operations. Kazaley Resources is a small mining company.

In a widely publicised move in 2005 it pegged the northwest Shovelanna iron ore deposit after the mining giant Rio Tinto failed to renew its lease in time. In April 2006 the then Minister for Resources terminated Kazaley's claim to this iron ore deposit. The matter

subsequently became the subject of Supreme Court proceedings initiated by Kazaley to have the minister's decision set aside. These proceedings are still ongoing.

Mr Burke and Mr Grill were retained by Kazaley during the course of 2006. This part of the hearing will examine the approach by Mr Burke to the Parliamentary Standing Committee on Estimates and Financial Operations to hold an inquiry into the iron ore policy of this state. As Mr Hall has already stated to the Commission in one of his openings earlier this week, standing committees of Parliament have significant powers including the holding of public hearings and the presentation of reports to the relevant house.

In this instance the standing committee was comprised of members of the Legislative Council and its functions included examining any matters relating to the financial administration of the state. This hearing will examine the motive behind the request for this hearing and whether there was an ulterior and improper purpose behind the requests for this inquiry.

Yesterday's hearing examined the 2004 inquiry by the Economics and Industry Standing Committee of the Legislative Assembly into vanadium resources at Windimurra. One matter that arises is whether there has been an attempt to misuse the functions of the Standing Committee on Estimates and Financial Operations and whether any public officer has engaged in misconduct in that attempt."

• Later in the transcript⁴ Mr Urquhart asks a number of questions of the Hon Shelley Archer:

"You're a member of the standing committee on delegated legislation?---

Yes, that's right.

That's a joint committee, is it?---Yes, it is.

Have you been in that committee since May of 2005?---I think so, yes.

Right and you're also a member of another committee?---Yes, I am.

Is that the standing committee on estimates and financial operations?---

That's correct.

Have you been on that committee since June of 2005?---That sounds about right.

Was that in fact the first time that committee was created?---Yes, it was."

I suggest to the Committee that a member or members of this Committee may have disclosed to the AMEC and the CCC matters discussed at a closed meeting.

The question of breach of privilege relates to four matters:

- 1. How did AMEC become aware of the proposed inquiry?
- 2. How did the CCC become aware of the proposed inquiry?
- 3. How did the CCC become aware of the date that the matters regarding the iron ore policy were discussed?
- 4. How could the CCC know about comments made during a closed meeting of the Estimates and Financial Operations Committee?

I therefore move pursuant to Standing Order 422 that this committee resolve to report the matter to the House.


