### REPORT OF THE STANDING COMMITTEE ON LEGISLATION

### REPORT 32: PILBARA PORTS ASSETS (DISPOSAL) BILL 2015 – EXTENSION OF TIME

- 1.1 On 22 March 2016, the Legislative Council referred the Pilbara Ports Assets (Disposal) Bill 2015 (Bill) to the Standing Committee on Legislation (Committee) for consideration and report by no later than 17 May 2016.
- 1.2 Pursuant to the motion of reference, the Committee has also been given the power to inquire into and report on the policy of the Bill.
- 1.3 As part of this inquiry, the Committee has contacted stakeholders and sought submissions relevant to the Bill. The Committee has encountered difficulties in scheduling regular meetings and hearings to progress this inquiry due to a concurrent inquiry being undertaken by the Committee with a very similar reporting date.<sup>1</sup>
- 1.4 The Committee also notes that the Legislative Council 2016-17 Budget Estimates hearings are scheduled for mid-June, which impacts upon the availability and workload of Committee Members and departmental representatives.
- 1.5 On 28 April 2016, the Committee resolved to seek the leave of the Legislative Council to extend the date by which the Committee is to report on the Bill from 17 May 2016 to 25 August 2016.
- 1.6 This extension is requested to enable the Committee to properly discharge its reporting obligations to the Legislative Council in light of the Committee's current workload, the complexities surrounding the Bill and the upcoming 2016-17 Budget Estimates hearings.
- 1.7 The Committee therefore requests an extension of time in which to report from 17 May 2016 to 25 August 2016.
