1. Meeting of Council

The Council assembled at 2.00pm pursuant to order.

The President, Hon Kate Doust, took the Chair.

Prayers and an Acknowledgement of Country were read.

The Minister for Environment made a Ministerial Statement with respect to the late tabling of 2018–19 Annual Reports of the Departments of Treasury, Landgate and the Fire and Emergency Services Superannuation Board.

5. Standing Committee on Procedure and Privileges — Report 57 — Legal Proceedings by the President — Further Authorisation by the Legislative Council

The President presented Report 57 of the Standing Committee on Procedure and Privileges, *Legal Proceedings by the President — Further Authorisation by the Legislative Council*. (Tabled Paper 3103). *Statement by President*

The President made the following Statement —

Members will recall that on 5 September 2019, the Legislative Council made a number of orders recommended by the Standing Committee on Procedure and Privileges in its fifty-sixth report. One of those orders was to authorise that legal proceedings be commenced on behalf of the Legislative Council, challenging the validity of some or all of three Corruption and Crime Commission notices to produce documents, and one notice to produce information served on the director general of the Department of the Premier and Cabinet between April and August 2019.

On 10 September 2019, the Corruption and Crime Commission served on the Clerk of the Legislative Council two notices to produce documents—"SAVE AND EXCEPT for any [content] which is determined by the Procedure and Privileges Committee of the Legislative Council to be subject to Parliamentary Privilege"—being the confidential email data and documents of three former members and their staff, which had been originally sought between

April and August 2019 from Mr Darren Foster, director general of the Department of Premier and Cabinet; and material on one former member's laptop and external hard drive.

As a legal and practical result of these two new notices to produce documents, the Committee recommends that the Legislative Council pass a further order updating its earlier order so as to reflect the changed circumstances arising from the two new Corruption and Crime Commission notices to produce documents and to facilitate the imminent commencement of the legal proceedings. The updates to the order of 5 September 2019 are to specifically address the following matters: (a) the addition of causes of action to the imminent legal proceedings relating to the two latest Corruption and Crime Commission notices to produce documents; (b) practical arrangements arising from the Clerk, as the recipient of the two new notices to produce, likely being a separate party to the imminent legal proceedings; and (c) consistent with the imminent legal proceedings, a direction to the Clerk that he is to provide the requested material to the Corruption and Crime Commission after the legal proceedings have been concluded and parliamentary privilege has been assessed in relation to the material or at the further direction of the Committee pursuant to legal advice.

For the information of the Legislative Council, the Committee advises that the drafting of the pleadings for the legal proceedings are well advanced and that the proceedings will be commenced shortly.

The Committee reiterates that it is not the intention of the Committee and the Legislative Council to impede the Corruption and Crime Commission's investigation. The Committee has at all times sought to work with the Corruption and Crime Commission to facilitate its investigation. The Committee is taking active steps to develop and implement a workable procedure, with the technical assistance of the Corruption and Crime Commission, for assessing those documents relevant to the Corruption and Crime Commission's investigation that may be subject to parliamentary privilege. Every action that the Committee has taken in this matter has been to protect those privileges of the Parliament that are critical to the proper functioning of Parliament and that enable Members of Parliament to perform their work representing constituents and holding the executive arm of Government to account unobstructed.
