- (d) Can the Minister confidently state that it is safe for blind people with guide dogs to navigate getting in and out of their vehicle at busy car parks and roadways, where they may be some distance from shopping centre and medical service entrances;
- (e) Will the Minister approve parking permits for some of or all guide dog users, considering that there are only approximately 57 guide dog users in the state, which would result in an increase of ACROD parking permits by 0.066%; and
- (f) Will the Minister consider a review of the ACROD parking permit eligibility to be consistent with New South Wales, Victoria, Tasmania and Victoria, and include those with severe visual impairment which affects their mobility, and if not why not?
