LEGISLATIVE COUNCIL

WEDNESDAY, 5 MAY 2021 1.00pm

1. Meeting of Council

The Council assembled at 1.00pm pursuant to order.

The President, Hon Kate Doust, took the Chair.

Prayers and an Acknowledgement of Country were read.

2. Death of Hon Clive Griffiths AO — Motion of Condolence

The Leader of the House moved, without notice —

That this House expresses its deep regret at the death of Hon Clive Griffiths, a former Member of the Legislative Council for the South Metropolitan Region and a former President of the Legislative Council; and places on record its appreciation for his long public service, and tenders its profound sympathy to members of his family in their bereavement.

The motion was supported by Members, including the President, and carried in silence; Members standing in their places.

3. Petitions

Hon Colin Holt presented a petition from 1,038 petitioners requesting the Legislative Council to oppose the Alcoa Huntly Mine expansion and the proposed increase in production at the Pinjarra Refinery and bauxite export. (Tabled Paper 153).

Hon Colin Holt presented a petition from 548 petitioners requesting the Legislative Council to investigate legislation and planning guidelines for the location, design and management of solid waste disposal sites and develop an exit plan for the Banksia Road Dardanup Waste Precinct and Landfill. Hon Colin Holt presented a petition from 829 petitioners requesting the Legislative Council to recommend to Main Roads WA that the speed limit on Bussell Highway be reduced along the Capel boundaries. (Tabled Paper 155).

Hon Colin Holt presented a petition from 280 petitioners requesting the Legislative Council to initiate an inquiry into community consultation and recommend that the State Government withdraw the current bio-security levy from the Shire of Bridgetown-Greenbushes. (Tabled Paper 156).

Hon Aaron Stonehouse presented a petition from 70 petitioners requesting the Legislative Council to oppose the allocation of a primary school site on Morfontaine Parade, Port Kennedy. (Tabled Paper 157).

6. Select Committee into the Transparency and Accountability of Government — Establishment

Motion No. 1 having been called, Hon Nick Goiran, pursuant to notice, moved —

- (1) A Select Committee into the Transparency and Accountability of Government is established.
- (2) The Select Committee is to
 - (a) inquire into the partial non-compliance by Hon Sue Ellery with an order of the Council made on 4 November 2020;
 - (b) identify and inquire into other instances of non-compliance during the 40th Parliament by Ministers with laws and conventions pertaining to transparency and accountability, including but not limited to compliance with section 82 of the *Financial Management Act 2006*;
 - (c) monitor compliance with such laws and conventions for the duration of the 41st Parliament and inquire into any instances of non-compliance;
 - (d) identify new proposals, initiatives and reforms that may enhance transparency and accountability of Ministers and the departments and agencies for which they are responsible; and
 - (e) consider any other relevant matter.
- (3) The Select Committee shall consist of 5 members and comprise a majority of non-government members which is to include at least three members of the official opposition;
- (4) The Chair of the Select Committee shall be a member of the official opposition;
- (5) The Select Committee shall report from time to time on its progress and table its final report by no later than 28 November 2024.

Debate ensued.

The Minister for Mental Health representing the Minister for Health, by leave, incorporated into *Hansard* information in relation to regional locations where state-run COVID-19 vaccinations can be accessed, in response to a question without notice asked by Hon Martin Aldridge.
