## 1. Meeting of Council

The Council assembled at 2.00pm pursuant to order.

The President, Hon Kate Doust, took the Chair.

Prayers and an Acknowledgement of Country were read.

## 2. Statement by President — COVID-19 Sitting Arrangements

The President made the following Statement —

I sent an email to all Members on Friday, 30 October 2020, advising arrangements that had been made for the coming sitting weeks.

I confirm that, I contacted Dr Andrew Robertson, Western Australia's Chief Health Officer, regarding seating arrangements in the Legislative Council. Following his advice and in consultation with Party Leaders, I am pleased to confirm a return to substantially normal Chamber operations.

## **Seating Arrangements**

Seating arrangements will return to normal and you will be able to speak from your allocated seat. The President's Gallery is no longer designated as part of the floor of the House.

## **Doors and Bar of the House**

Chamber doors will return to being closed and will be manned by Chamber staff at the usual times, for example during Divisions. The Bar of the House will return to its usual closed position during sitting.

## **Hygiene and Social Distancing**

Admission to the Chamber is subject to all persons strictly adhering to hygiene requirements. Hand sanitiser is available at each of the entrances to the Chamber and all persons are required to use this on entry to the Chamber. Please also follow other health guidelines including only attending if you are well, coughing / sneezing into your elbow or a tissue and immediately discarding it in a bin.

#### Advisers

Arrangements for Government advisers sitting behind the President's dais return to normal. During Committee of the Whole, advisers will continue to sit at the table of the House along with the Minister.

### Committee of the Whole

The Chair of Committees and Deputy Chairs will sit at the Clerk's Table during Committee of the Whole House.

#### **Divisions**

Divisions will be conducted with Members crossing the Chamber. Those voting with the Ayes will move to the right of the Chair and those voting with the Noes will move to the left.

## **Question Time**

Hard copy answers will continue to not be distributed in the Chamber. Answers will be provided to Members by email via the Parliamentary Liaison Officer to minimise staff movement in the Chamber and handling of papers. Should you require a hard copy, please advise the Parliamentary Liaison Officer who can print this for you to collect after Question Time.

## **Public Gallery**

The Public Gallery will remain closed to the general public, with the exception of guests attending the Legislative Council as part of Condolence Motion debates.

#### Hansard

Hansard will return to normal in-Chamber reporting.
