215. Hon Martin Aldridge to the Leader of the House representing the Minister for Emergency Services:

I refer to question without notice No. 164 asked in the Legislative Council on 26 May 2021, regarding the emergency situation declarations under section 50 of the *Emergency Management Act 2005* in relation to the Wooroloo bushfire and tropical cyclone Seroja, and I ask, have impact statement's been prepared and provided to affected local government authorities and, if so, can the Minister please table each impact statement?

I refer to warnings issued by the Therapeutic Goods Administration (TGA), specifically in a media release dated 3 May 2021, around the dangers inherent in buying medicinal cannabis products online, and I ask, given the clear risks associated with online, and in many cases black market products of this nature, which the TGA concedes are often viewed as "a simple, affordable option", what steps is the McGowan Government taking to lower the cost of, and increase access to, genuine medicinal cannabis products in Western Australia?

I refer to the Department of Health's most recent workforce analysis undertaken to determine staffing requirements needed within the Metropolitan Child Development Service to address current and future demand, and I ask:

 - (i) speech pathology;
 - (ii) occupational therapy; and
 - (iii) paediatric services?
