 - (d) what, if any, training has been or is provided to volunteers in the victim support services; and
 - (e) who is responsible for developing and providing training to volunteers in victim support services;

- (a) what ongoing noise monitoring and evidence-based assessment has been, or is currently undertaken in the proposed Northbridge Special Entertainment Precinct 'core' and 'frame' areas to inform the Government's decision making;
- (b) could the Minister please specify the location of any and all noise monitoring stations in this area:
