3. Statement by President — Usher of the Black Rod

The President made the following Statement —

Following Dr Paul Lobban's departure from the Legislative Council, Grant Hitchcock has been acting in the role of Usher of the Black Rod. As this role and the position of Advisory Officer (Procedure) were established on a rotational basis, I am pleased to advise that Grant has now been formally rotated into the role of Usher of the Black Rod, effective from 13 July 2015. Grant is the seventeenth permanent Usher of the Black Rod since the establishment of responsible government in 1890.

For the interest of Members, the Usher of the Black Rod dates back to fourteenth century Britain. The Usher was appointed to serve the monarch in the British House of Lords and was originally an officer of the Most Noble Order of the Garter, a British order of knighthood. The garter, or "belt", forms part of the royal coat of arms, which members can see on top of the dais behind me. The Black Rod was used to discipline anyone who offended the order. Under our Parliament's inherited privileges, the Usher retains the power of arrest and serves as the personal attendant to the Governor when on the parliamentary precincts. On behalf of all Members, I congratulate Grant on his appointment, and wish him every success in his new role.
