LEGISLATIVE COUNCIL

TUESDAY, 25 MAY 2021 2.00pm

1. Meeting of Council

The Council assembled at 2.00pm pursuant to order.

The Clerk, Mr Nigel Pratt, took the Chair.

2. Election of the President

The Clerk announced that in accordance with the provisions of the *Constitution Acts Amendment Act 1899* the Office of the President was vacant, whereupon the Leader of the House, addressing the Clerk, moved, without notice —

That Hon Alanna Clohesy do take the Chair in the Council as President.

Hon Dr Steve Thomas seconded the motion.

No other Member being proposed and Hon Alanna Clohesy having accepted the nomination, Hon Alanna Clohesy was conducted to the Chair by her proposer and seconder.

The President made the following Statement —

I begin by acknowledging the traditional owners of the land that we meet on today, the Whadjuk people of the Noongar nation. I pay my respects to elders past and present and emerging. I extend that respect to all traditional owners across our great state and to all Aboriginal and Torres Strait Islander people here today.

Thank you, Members, for placing your trust in me through election as your President. It is a great honour and a role that I commit to undertaking with fairness, integrity and hard work. I am aware that, since 1890, only 18 Presidents before me have had this honour. I acknowledge all the Presidents who have served before me, especially those who have held the position during my time in this place: Hon Kate Doust and Hon Barry House. I thank them for their service and contribution, unique to each of them.

Our daily work in this Chamber is surrounded and informed by history, traditions and conventions. This magnificent building is a constant reminder of where we have come from. But as a modern Parliament, we can and do examine the importance of continuing traditions and their symbolic meaning. The opening of the forty-first Parliament, just recently, for example, combined old and ancient traditions. For the first time, we were privileged to be welcomed to country by Whadjuk elder Dr Richard Walley in this Chamber. I am sure Members will agree that this new tradition of acknowledgement, respect and reconciliation is one to be welcomed. It has both symbolic and substantive value to us all.

I have thought carefully about the symbolic traditions of this office. To this end, Members may have noticed that I am not wearing the traditional Presiding Officer's robe. I hope that, in doing so, my term will be marked by the value of fairness, rather than by traditional

symbols of office. Similarly, forms of address can reflect certain values. It is my preference that the title of the position of President be used by Members without the gendered honorific of Madam, when possible. This change reflects an important substantive value that I trust we all share, that of equality.

Members, we have much work ahead of us and how we carry out that work is as important as the work itself. I take this opportunity to especially acknowledge all the new Members in this Chamber. I undertake to work with new Members to demystify, as much as possible, the various traditions and conventions that inform our work so that we might all fulfil our roles with clarity and confidence. Another important part of modern parliamentary work is engaging with our community to involve people in the work that we do here. I hope to support and enhance the good work already underway in this area. Similarly, engaging with members of the public here in our most privileged of workplaces, the Parliament, will be another focus of my attention.

Members, in this Legislative Council, respect for all in our community and for each other should underpin all we do here. I am honoured to be your President of the forty-first Parliament. I wish all Members the very best for your work over the next four years.

The President received the congratulations of the Council.

12. Temporary Order — COVID-19 Arrangements

The Leader of the House moved, without notice —

If, following agreement with the party leaders or Members deputed, the Leader of the House or the Member deputed by the Leader advises the House that it is necessary to introduce a Government Bill or undertake any other immediate business arising from or in connection to COVID-19, the following Temporary Order shall apply in respect of those matters:

- (1) Any business then before the House, other than formal business, a matter of privilege, or a motion subject to SO 67 shall be adjourned to a later hour.
- (2) Any such Bill may be introduced without notice and shall proceed through its stages at dates and times determined by the House.

- (3) Any such Bill the subject of a Message from the Legislative Assembly may be taken into consideration on the day on which it is received.
- (4) On any sitting day, and after first consulting with the party leaders or Members deputed, the President may order that one or more of the following items of business in the order of business for that day be dispensed with:
 - (a) Non-Government Business;
 - (b) Private Members' Business; and
 - (c) Consideration of Committee Reports.
- (5) If ordered, the Council shall sit beyond the following times on the days specified until Members' Statements are called by the President and, in such case, SO 5(5) applies:

Tuesday 9.45pm;

Wednesday 6.20pm; and

Thursday 5.20pm.

- (6) After first consulting with the party leaders or their representatives, the Leader of the House or a Member deputed may set maximum time limits for each stage of a Bill or a motion and on the expiry of that maximum time limit all questions relating to the stage of a Bill or motion, including any amendment, shall be put and determined *seriatim*.
- (7) A requirement for notice to be given in respect to any motion to be moved by the Leader of the House or a Minister is dispensed with.
- (8) That, in the event that a scheduled sitting day of the House does not take place, the usual process for Questions on Notice that would have occurred on that day, shall still occur.
- (9) Standing Orders are suspended accordingly to the extent necessary to effect these arrangements.
- (10) This Temporary Order to apply until 2 December 2021 or the lifting of the state of emergency declared in Western Australia arising from the COVID-19 pandemic, whichever occurs first.

Debate ensued.

The President having counted the Council, and there being an absolute majority present, and no dissentient voice, declared the motion carried with the concurrence of an absolute majority.

SCHEDULE

10. Joint Delegated Legislation Committee

- 10.1 A *Joint Delegated Legislation Committee* is established.
- 10.2 The Committee consists of 8 Members, 4 of whom are appointed from each House. The Chair must be a Member of the Committee who supports the Government.
- 10.3 A quorum is 4 Members of whom at least one is a Member of the Council and one a Member of the Assembly.
- 10.4 (a) A report of the Committee is to be presented to each House by a Member of each House appointed for the purpose by the Committee.
 - (b) Where a notice of motion to disallow an instrument has been given in either House pursuant to recommendation of the Committee, the Committee shall present a report to both Houses in relation to that instrument prior to the House's consideration of that notice of motion. If the Committee is unable to report a majority position in regards to the instrument, the Committee shall report the contrary arguments.
- 10.5 Upon its publication, whether under section 41(1)(a) of the *Interpretation Act 1984* or another written law, an instrument stands referred to the Committee for consideration.
- 10.6 In its consideration of an instrument, the Committee is to inquire whether the instrument
 - (a) is within power;
 - (b) has no unintended effect on any person's existing rights or interests;
 - (c) provides an effective mechanism for the review of administrative decisions; and

- (d) contains only matter that is appropriate for subsidiary legislation.
- 10.7 It is also a function of the Committee to inquire into and report on
 - (a) any proposed or existing template, pro forma or model local law;
 - (b) any systemic issue identified in 2 or more instruments of subsidiary legislation; and
 - (c) the statutory and administrative procedures for the making of subsidiary legislation generally, but not so as to inquire into any specific proposed instrument of subsidiary legislation that has yet to be published.
- 10.8 The Standing Orders of the Legislative Council relating to Standing Committees will be followed as far as they can be applied.
- 10.9 In this order -

"instrument" means -

- (a) subsidiary legislation in the form in which, and with the content it has, when it is published;
- (b) an instrument, not being subsidiary legislation, that is made subject to disallowance by either House under a written law; "subsidiary legislation" has the meaning given to it by section 5 of the *Interpretation Act 1984*.
