1. Meeting of Council

The Council assembled at 1.00pm pursuant to order.

The President, Hon Alanna Clohesy, took the Chair.

Prayers and an Acknowledgement of Country were read.

2. Statement by President — Tabling of Parliamentary Departments 2021-2022 Annual Reports

The President made the following Statement —

I have received letters from the Clerk of the Legislative Council, Clerk of the Legislative Assembly and the Executive Manager of Parliamentary Services advising me that they will not be able to present their Departments' 2021-22 Annual Reports within the prescribed 90-day period after the end of the 2021-22 financial year, as required under section 64(1) of the *Financial Management Act 2006*.

This is because the Office of the Auditor General is unable to provide their audit opinions within the usual timeframe.

It is anticipated the Annual Reports will be tabled in both Houses of Parliament on 15 November 2022.

12. President's Ruling — Matter of Privilege raised by Hon Nick Goiran

The President ruled as follows —

On Thursday, 1 September 2022 the Hon Nick Goiran raised a matter of privilege, which I undertook to consider and report back to the House.

The Hon Nick Goiran proposed that in answering a question on behalf of the Minister for Child Protection, the Hon Sue Ellery had provided a false answer.

The relevant part of the answer provided by the Leader of the House at Question Time was:

(1) Workload management reporting is a point-in-time report produced on the first Friday of every month. The Honourable Member's question was asked on 10 August 2022, so the most recent finalised results for July 2022 were provided.

The assumption that underpins the Hon Nick Goiran's claim that the answer provided was untrue, is that the Leader of the House should have provided the figures from the point-in-time report produced on 5 August 2022.

While it is not my intention to undertake a forensic review of the matter, I would point out that the Leader of the House provided 'the most recent finalised results for July 2022'. It may have been the case that the point-in-time report produced on 5 August 2022 had not yet been finalised on 10 August 2022 when the answer was provided.

In any event, as the Hon Nick Goiran noted on 1 September all of the information he requested has now been provided.

Accordingly, I rule that there is no substantive matter of privilege to be investigated.
