*Deputy Speaker's Statement – Printing Error in the Strata Titles Amendment Bill 2018*

The Deputy Speaker directed members' attention to the bottom of page 209 and the top of page 210 of the Bill and pointed out an error in the numbering of the sub-paragraphs. Members were advised that as this was a printing error, the numbering of the sub-paragraphs would be corrected as a clerical correction before the Bill passed both Houses.

**14. Industrial Hemp Amendment Bill 2018**

Message No. 43 dated 21 August 2018 from the Legislative Council was reported forwarding for concurrence a bill for “An Act to –

- amend the *Industrial Hemp Act 2004* to increase the permitted level of tetrahydrocannabinol in industrial hemp to no more than 1%; and
- consequentially amend the *Misuse of Drugs Act 1981*.”

Ordered, That the first reading of the bill be made an Order of the Day for the next sitting of the Assembly.
