The President ruled as follows —

We have had this discussion previously on a similar type of cognate debate and the Bills had been split up. One bill had been referred to the other place for an amendment, and the primary Bill, if you like, had remained in this place for completion. We are in the same situation with these Bills, this Bill, the *Environmental Protection Amendment Bill 2020*, and the *Environmental Protection Amendment Bill (No. 2) 2020*, which has been sent to the other place. They have now been split up. This Bill will be dealt with separately, and in due course I anticipate that the other Bill will be returned to this place, perhaps with an amendment, and will be dealt with in due course.
