1. Meeting of Assembly

The Assembly met at 2.00 pm pursuant to adjournment.

The Speaker took the Chair.

An Acknowledgement of Country and Prayers were read.

2. Death of Arthur Marshall OAM - a former Member of the Legislative Assembly

The Premier, without notice, moved,

That the House records its sincere regret at the death of Arthur Marshall and tenders its deep sympathy to his family.

The motion was supported by Dr M.D. Nahan, Ms M.J. Davies, Mrs M.H. Roberts, Mr J.E. McGrath, Mr D.A. Templeman, Mr P.J. Rundle, Mr M.P. Murray, Mr D.C. Nalder and Mr Z.R.F. Kirkup.

Question put and passed unanimously with members and officers of the Assembly standing in their places as a mark of respect.

- (1) while the member for Central Wheatbelt was on her feet speaking to the motion to suspend standing orders last Thursday, the Minister for Water:
 - (a) passed between her and the Chair;
 - (b) was in very close proximity;
 - (c) seemed to lean in as he went by; and
 - (d) very pointedly looked directly at her; and
- (2) his behaviour was disconcerting and bordering on intimidatory.

15. Heritage Bill 2017

The Order of the Day for the further consideration in detail of the bill was read.

CONSIDERATION IN DETAIL

Clauses 15 to 36 agreed to. New Division 1A. Mr V.A. Catania moved, Page 23, after line 24 – To insert:

Division 1A – Three Jetties

36A. **Three Jetties**

The Carnarvon One Mile Jetty, Esperance Tanker Jetty and Busselton Jetty ("the Three Jetties") shall be deemed, for the purposes of this Act –

- (a) to be places of cultural heritage significance that make an important contribution to understanding the heritage of Western Australia and are to be protected and preserved; and
- (b) to be the appropriate recipients of funding granted annually to ensure that they are maintained.

36B. **Protecting and Preserving Three Jetties**

The Minister and the Council, in protecting and preserving the Three Jetties, may consider the use of modern alternative structural materials for the internal structure of pilings to ensure the long-term sustainability of each of the Three Jetties, but the outwards wooden appearance of each of the Three Jetties must be maintained.

36C. **Access to Three Jetties**

The Minister and the Council must ensure that:

- (a) the public has access to some areas of each of the Three Jetties free of charge, unless maintenance is being undertaken which would create an unsafe environment for public use or significant damage from natural events has occurred that has caused the entire structure or parts to be closed; and
- (b) each of the Three Jetties are made available to industries such as tourism, commerce and small business on a fair and equitable basis.
