1428. Hon Dr Brad Pettitt to the Minister for Agriculture and Food representing the Minister for Housing:

I refer to to the public housing wait list and priority housing wait list respectively, and I ask:

- (a) how many applicants and individuals were on each list on 31 March 2023;
- (b) for the 12 month period ending April 2023, what was the average wait time for each list broken down by region and applicant type; and
- (c) will the Minister commit to re-commencing publication of a housing dashboard of key public housing statistics like these on a monthly basis, without the need for non-government MP's to use up questions during question time, as is done in other Australian jurisdictions?

1429. Hon James Hayward to the Leader of the House representing the Minister for Health:

I refer to the practice of employing short term staff from contract agencies to ensure hospitals are staffed with enough nurses, and I ask:

- (a) what was the total amount spent by the Department of Health on agency nurses in the 2021-22 financial year;
- (b) what is the total amount spent by the Department of Health on agency nurses in the current financial year to date;
- (c) what operational issues are caused by a reliance on agency staff who may not be aware of specific policies and procedures implemented by the hospital they are working at for a short amount of time; and
- (d) will the Minister agree to wage and condition demands from nurses employed directly by the Department of Health to reduce the reliance on agency staff?

1430. Hon Tjorn Sibma to the Parliamentary Secretary representing the Minister for Corrective Services:

- (1) How many persons are currently subject to a supervised parole order?
- (2) How many of these parolees are subject to wearing an electronic device as a condition of their parole?
- (3) How many persons, currently subject to a supervised parole order, have whereabouts unknown?
- (4) Regarding question (3):
 - (a) how long has each parolee's whereabouts been unknown; and
 - (b) for each parolee with whereabouts unknown, what offenses had they been found guilty of?

- (c) of those parolees whose parole was cancelled by reason of their whereabouts being unknown, for how many days were their whereabouts unknown prior to cancellation of their parole?

I refer to the role of WA Police in the execution of return to prison warrants, and I ask:

- (a) how many police officers have been involved in such warrants in the current financial year;
- (b) what has been the average number of days between the date of issue and the date of service of these warrants; and
- (c) (c) for how many days has the oldest warrant been outstanding?

1434. Hon Dr Brad Pettitt to the Parliamentary Secretary representing the Minister for Corrective Services:

I refer to youth justice, and I ask:

- (a) how many major riots or incidents, defined as an incident where more than three detainees have escaped their cells, have occurred at Banksia Hill Detention Centre since 2013; and
- (b) if data back to 2013 is not able to be provided, could the Minister please provide the number of major incidents back to the earliest year where data is available?
