3. Shire of Murray Bush Fire Brigades Local Law 2023 — Disallowance

5. Western Australia Health System

Hon Martin Aldridge: To move on the next day of sitting —

That the Legislative Council —

- (a) expresses our gratitude to frontline healthcare workers, healthcare providers and non-government organisations for their outstanding contribution to the health of all Western Australians through recent periods of great uncertainty; and
- (b) notes the McGowan and now Cook Labor Government's mismanagement of the health system, which has been plunged into crisis after crisis and has resulted in numerous devastating and preventable incidents; recordambulance ramping; and all-time low staff morale.

6. Native Timber Industry Closure Impact Assessment Committee

Hon Louise Kingston: To move on the next day of sitting —

- (1) A Select Committee to be known as the Native Timber Industry Closure Impact Assessment Committee is established.
- (2) The Select Committee is to inquire into and report on
 - (a) the direct economic and social impact of the closure of the native timber commercial logging industry;
 - (b) the indirect economic and social impact of the closure of the native timber commercial logging industry;
 - (c) the Forest Products Commission's ability to meet remaining contractual obligations for the delivery of native timber sawlog supplies;
 - (d) the Western Australian Government's softwood plantation investment plan and its ability to fill short-term demand following the closure of the native timber commercial logging industry; and
 - (e) the effectiveness of the State Government's Native Forest Transition plan, including but not limited to business, workforce, industry, and community.
- (3) The Select Committee is to report no later than 12 months after the motion is agreed to.
- (4) The Select Committee shall consist of no fewer than four members.

7. Consultation processes — Government failure

Non-Government Business No. 1 having been called, Hon Colin de Grussa moved, without notice — That this House —

- (a) recognises the pivotal role of genuine consultation with the public in delivering improved outcomes for both communities and Government;
- (b) notes recent examples of flawed and failed consultation processes by the Cook Labor Government as instances where genuine good faith consultation did not occur; and
- (c) calls upon the Cook Labor Government to take immediate corrective measures and commit to open and transparent consultation processes to ensure the best outcomes for our State.

13. Statement by President — Staff Appointments

The President made the following Statement —

I wish to advise Members of a number of recent staff appointments.

At the commencement of the next sitting week, you will hear an unfamiliar voice as I am announced by our new Usher of the Black Rod, Mr Daniel Beresford-Long. Mr Beresford-Long will be the Legislative Council's nineteenth Usher of the Black Rod since the establishment of Responsible Government in 1890.

Mr Beresford-Long joins us from Landgate where he has held senior management roles focused on governance, policy, innovation and business analytics.

In a modern context, the Usher of the Black Rod undertakes two roles. In this House, they serve as the personal attendant to the Governor when on the Parliamentary Precinct and they enforce the directions of the President to ensure order. The Usher also plays an important corporate role for the Department of the Legislative Council, assisting in the areas of compliance, project management and delivery of strategic projects.

The Usher of the Black Rod role periodically rotates with the Advisory Officer (Procedure) role. I am pleased to advise that Ms Renae Jewell has been appointed to the Advisory Officer (Procedure) role. Renae first joined Parliament in 2004 and has worked across the two Chamber departments in various roles. She has most recently undertaken the roles of Parliamentary Officer (Procedure) and Deputy Usher of the Black Rod in the Legislative Council's Procedure Office. I am sure that Members will attest to the quality of service that Renae always delivers.

The Department is fortunate to have attracted talented and dedicated staff to these important roles. I wish Renae and Daniel well as they work collaboratively with the Clerk to deliver the Department's high level of service to Members and the broader community.
