# 2. Statement by President — 2020–2021 Budget Estimates and 2019–2020 Annual Report Hearings

The President made the following Statement —

Members, I have a piece of correspondence from the Standing Committee on Estimates and Financial Operations that states —

Dear Madam President

2020-2021 Budget Estimates; 2019-20 Annual Reports hearings

Thank you for your letter granting permission for the Standing Committee on Estimates and Financial Operations to hold the 2020–21 Estimates hearings in the Legislative Council Chamber.

I request you advise the House about the following administrative procedures for the Estimates hearings given that the week chosen is earlier than previous years and means the Inquiry must be truncated.

- (1) Estimates hearings will be held between Monday, 8 June and Thursday, 11 June 2020 inclusive.
- (2) Members may nominate agencies to appear by 5pm, Tuesday, 12 May.
- (3) A timetable of those agencies chosen to appear and the Procedure Policy will be emailed to Members as soon as possible after 21 May.
- (4) No questions prior to hearings will be permitted. This is because there is insufficient time for Members to submit questions, Ministers to provide answers before the hearings and the Committee to assign status to answers.
- (5) The electronic lodgement system will open on the first day of the hearings for additional questions and will remain open until 5pm, Friday, 26 June.

With respect to Annual Reports hearings, please advise the House that:

(1) Annual Reports hearings will be held across three sitting weeks on Mondays: 12 October, 19 October and 2 November 2020 as well as Wednesdays: 14 October and 21 October 2020.

- (2) Members may nominate agencies to appear by 5pm, Monday, 21 September.
- (3) A timetable of those agencies chosen to appear and the Procedure Policy will be emailed to Members as soon as possible after 23 September.
- (4) No questions prior to hearings are permitted.
- (5) Additional questions from the hearings are permitted with answers to questions on notice due by Friday, 30 October.
