- (c) Does the Parliamentary Counsel's Office continue to engage contract drafters which are made of retired legislative drafters;
- (d) How many Bills are currently the subject of drafting instruction;
- (e) How many regulations are currently the subject of drafting instruction; and
- (f) Is the Government's legislative program continuing to challenge the Parliamentary Counsel office's resources?
