- (1) On 17 June 2022, the Minister for Regional Development announced that a pre-feasibility study for the proposed magnesium smelter in Collie had been completed. Can the Minister provide the study?
- (2) The 17 June 2022 press release stated that the Government was investing \$2 million into a feasibility study into the provision of magnesium hydroxide as a byproduct of desalination for the proposed smelter. Has this study been completed and, if so, is it available to the public?
- (3) Does the project proponent (Magnium Australia (Magnium)) currently operate any other manufacturing or processing facilities in or outside Australia? If so, what facilities do they currently operate?
- (4) The 17 June 2022 press release mentioned that Magnium would commercialise a breakthrough technology developed by the Commonwealth Scientific and Industrial Research Organisation (CSIRO) for producing magnesium metal.
 - (a) What is the name of the breakthrough CSIRO technology;
 - (b) What is the largest scale that the technology has operated at (daily throughput or maximum batch production); and
 - (c) What was the fuel/reductant used in these production trials (carbon/coal/hydrogen/other?) please name?
- (5) Will the Magnium proposed process be using coal in their process as the fuel/reductant?
- (6) If the Magnium process does not use coal as the fuel/reductant for their process, what other fuel/reductant will they be using?
- (7) Will the Magnium process be using green hydrogen and, if so, what percentage of the fuel/reductant mix will be provided by hydrogen?
- (8) If the Magnium process proceeds at Collie at the announced rate of 100,000 tonnes magnesium production per year, what is the anticipated approximate amount of carbon dioxide equivalent emissions?
- (9) When does the Government believe that the Magnium project will commence construction?
- (10) When does the Government believe that the Magnium project will be commissioned?
- (11) Has the Government (Ministers or Departmental officials) held any discussions with unions and/or community groups in Collie about a proposed commencement date for the proposed magnesium smelter?
- (12) How many jobs does the Government anticipate the Magnium project will generate during both construction and operational phases?
