- (b) The two inspectors who where at the shaft when the alleged direction was given (the mechanical engineer and the District Inspector) both denied giving such a direction. They both assumed the direction was given by the R.M.E.
- (c) There was no evidence of the direction by a Record Book entry. The R.M.E apparently failed to check that facet of the matter.
- (d) The underground manager for the shaft indicated that he was verbally directed by the District Inspector to cease using the cages and that miners would have to climb to the surface.
- (e) It was pointed out that the Registered Manager for the Shaft contacted the R.M.E and showed his concern about the miners having to climb to the surface. The D.M.E did not react positively to that concern and certainly did not inspect the site to assess the situation first hand.
- (f) Overall, there appeared to be a high degree of confusion about the whole matter. Nobody was prepared to accept the responsibility for the events.'?

- (3) Does Main Roads liaise with other Government departments such as the Department of Environment and Heritage, Department of State Development and the Department of Agriculture to ascertain whether the clearing on roadside trees and vegetation is carried out with a consideration of salinity salt levels, soil and land conservation and biodiversity issues in mind?
- (4) Has Main Roads contracted the removal of roadside trees to private company?
- (5) If yes to (4), is this contract applicable to roads throughout the States?
- (6) If yes to (4), what company/companies has/have been contracted to carry out this work?
- (7) What guidelines do the contracted company/companies follow when clearing roadside trees and vegetation?
- (8) What tonnage of vegetation has Main Roads cleared from roadsides throughout Western Australian over the last six months?
