### 16. Matter of Public Interest – Review of Demersal Scalefish Policy

The Deputy Speaker informed the Assembly that he was in receipt of a notice from Mr R.S. Love that he intended to move a motion on a matter of public interest.

At least five members having risen in support,

Mr R.S. Love moved,

That this House:

- (1) recognises the irreplaceable economic, social, and public health value fishing brings Western Australia and calls on the Minister for Fisheries to:
  - (a) review his policy to ban fishing for demersal scalefish, including Pink Snapper and Black Dhufish, for as much as nine months of the year;
  - (b) develop a plan for the West Coast Fishery that balances community, economic, and environmental outcomes; and
- (2) acknowledges the more than 18,000 West Australians who have petitioned the Minister to conduct such a review.

Debate ensued.
