#### **MOTIONS**

**1. Climate Change** (Notice given 14 March 2023)

Hon Shelley Payne: To move —

That the Legislative Council —

- (a) recognise that climate change has a profound and detrimental impact on the availability of water resources in Western Australia, particularly in the south-west of Western Australia and the Perth metropolitan region; and
- (b) commend the McGowan Labor Government for its leadership in developing policies and initiatives to address these climate change impacts on our precious water resources.
- **2. Government Trading Enterprises** (Notice given 21 March 2023)

Hon Dr Steve Thomas: To move —

- (a) notes the Government's inability to provide proper oversight and transparency in relation to Government trading enterprises;
- (b) notes section 6 of the *Gold Corporation Act 1987* that allows the Minister to request any information from Gold Corporation under section 6(9) and that Gold Corporation must comply with that request under section 6(10);
- (c) notes that section 6(7) of the Act states that "Gold Corporation shall furnish to the Minister all information in the possession of Gold Corporation relating to the business of Gold Corporation" for Parliamentary purposes, which according to the Act in section 6(11) includes the answering of questions

and "complying with a written law, or an order or resolution of a House of Parliament, that requires information to be furnished to a House of Parliament"; and

(d) calls on the Minister for Mines and Petroleum to have tabled in the Legislative Council the minutes of the Gold Corporation's meetings in 2021, 2022 and 2023.

#### **3.** Plastic Waste in Western Australia (Notice given 29 March 2023)

Hon Dr Sally Talbot: To move —

That the Legislative Council commends the McGowan Labor Government's ongoing commitment to innovation and leadership in management of plastics including the strategic reduction, reuse, and management of plastic waste in Western Australia.

#### **4. Indigenous Voice to Parliament** (*Notice given 16 May 2023*)

Hon Rosetta Sahanna: To move —

That the Legislative Council supports the proposal to recognise the First Peoples of Australia in the Constitution and establish an Indigenous Voice to Parliament.

#### **5. E-Petitions** — **Disparaging remarks of the Premier** (*Notice given 21 June 2023*)

Hon Nick Goiran: To move —

- (a) expresses its concern with the disparaging remarks of the Premier on 20 June 2023 regarding official parliamentary petitions hosted on the portal established through the Parliament of Western Australia's website;
- (b) has considered and had particular regard for the recommendations contained in a number of reports from the Standing Committee on Procedure and Privileges in the period 2016 to 2023, which were the genesis to the establishment of official parliamentary e-petitions:
  - (i) Report 40, E-Petitions, 28 June 2016;
  - (ii) Report 45, Outstanding Matters from the 39th Parliament, 24 August 2017; and
  - (iii) Report 64, Review of the Standing Orders, 2 September 2021;
- (c) thanks the Members and staff of the Standing Committee for their subsequent review of e-petitions which manifested in Report 69 being tabled in February 2023;
- (d) notes the Standing Committee was satisfied that the process was operating effectively;
- (e) acknowledges and affirms the right to petition;
- (f) encourages the Premier to familiarise himself with that right, which was established in 1215 under the *Magna Carta*;
- (g) further encourages the Premier to read Article 5 of the *Bill of Rights 1689* which reaffirmed that right;
- (h) recommends that the Premier obtain a briefing from the Attorney General or the Solicitor General to ensure he is clear on this right held by all Western Australians; and
- (i) calls on the Premier to listen to the grievances and requests of Western Australian petitioners and desist from treating those concerns with disdain.

#### **6. Fishing Industry — Government Compensation** (Notice given 18 October 2023)

Hon Colin de Grussa: To move —

That the Legislative Council —

- (a) acknowledges the invaluable economic and social contribution of the fishing industry to our State;
- (b) recognises the impacts of government processes in establishing marine reserves and managing fishing industries with regard to
  - (i) the potential effects on the future viability of Western Australia's world class commercial and tourism fishing industries; and
  - (ii) the potential impacts on food security and tourism due to the sourcing of fish products from international markets; and
- (c) urges the Government to commit to enhancing statutory and compensatory mechanisms to provide fair and timely compensation to operators affected by Government actions.

#### **7. Western Australia Health System** (*Notice given 19 October 2023*)

Hon Martin Aldridge: To move —

That the Legislative Council —

- (a) expresses our gratitude to frontline healthcare workers, healthcare providers and non-government organisations for their outstanding contribution to the health of all Western Australians through recent periods of great uncertainty; and
- (b) notes the McGowan and now Cook Labor Government's mismanagement of the health system, which has been plunged into crisis after crisis and has resulted in numerous devastating and preventable incidents; recordambulance ramping; and all-time low staff morale.
- **8. Government Budget Surplus** (Notice given 9 November 2023, amended 15 November 2023)

Hon Dr Steve Thomas: To move —

- (1) Notes that
  - (a) the 2023-24 Government Mid-year Financial Projections Statement, also called the Mid-year Review, released in December 2023 has again shown that the Cook Labor Government has underestimated State revenue for this financial year, especially iron ore royalties revenue;
  - (b) the latest figures are again predicting a multi-billion dollar surplus for Western Australia;
  - (c) Western Australian residents and families continue to struggle with higher cost of livings while the Cook Labor Government continues to roll in and flaunt its wealth, which it owes to high international iron ore prices rather than their own financial management.
- (2) Calls on the Cook Labor Government to urgently do more for struggling Western Australian residents and families.

#### **9. Armadale line shutdown** (*Notice given 14 November 2023*)

Hon Tjorn Sibma: To move —

That this House notes –

- (a) the Minister for Transport's decision to shut down the Armadale line for at least 18 months from 20 November 2023;
- (b) the cost and inconvenience of this decision which further exacerbates the financial costs of the METRONET project;
- (c) the hallmark secrecy which surrounded this decision and the ensuing inadequate consultation with passengers;
- (d) the Minister's failure to provide any compelling evidence that this shutdown is the best solution to facilitate the METRONET program of works; and
- (e) the absence of any plan to mitigate the potential for the shutdown extending beyond 18 months, and the impacts this will have on many commuters across the metropolitan area.

### **10.** Responsible exercise of the Corruption and Crime Commission's powers (Notice given 29 November 2023)

Hon Nick Goiran: To move —

- (a) notes with appreciation the Parliamentary Inspector of the Corruption and Crime Commission's report of 27 November 2023 correcting the errors and omissions contained in the Corruption and Crime Commission's (CCC) report of 12 March 2019;
- (b) endorses the Parliamentary Inspector's conclusion that it is not a responsible exercise of the CCC's powers to report to Parliament speculating that a person has 'possibly' committed an offence in a situation where it does not know whether a person has committed a criminal offence, and where it has not conducted sufficient research to determine the matter;
- (c) notes with concern the CCC's refusal to prepare a supplementary report to address the errors and omissions;
- (d) thanks Parliamentary Inspector Matthew Zilko SC for his continued service as a monitor on the operation of the *Corruption, Crime and Misconduct Act 2003*;
- (e) expresses its appreciation to the members and staff responsible for the drafting, tabling and publishing of Report 61 of the *Standing Committee on Procedure and Privileges*;
- (f) notes that the Committee's audit revealed that 1,120 privileged documents were provided without parliamentary approval by the Government to the
- (g) reasserts that draft parliamentary speeches, motions and questions are subject to parliamentary privilege in the same way as confidential parliamentary committee material such as committee deliberations and draft report recommendations; and
- (h) reminds the CCC that the legislature has entrusted it with extraordinary powers and that its immunity from defamation actions and other claims for damages highlight why those powers must be exercised with caution and prudence.

#### **11. Bicentennial Anniversary Celebrations** (*Notice given 27 February 2024*)

Hon Tjorn Sibma: To move —

That this House -

- (a) acknowledge the year 2029 will mark the bicentennial anniversary of the foundation of Perth and Fremantle, and the establishment of the Swan River Colony;
- (b) additionally, acknowledge that 2026 will mark the bicentennial anniversary of the establishment of a British presence at Albany;
- (c) that these historic moments set the trajectory for the development of modern Western Australia, subsequently forming part of the Commonwealth of Australia;
- (d) that the commemoration and celebration of these milestones provides an opportunity for all Western Australians, of all backgrounds, both to reflect upon the achievements of our State, and upon our shared aspirations as a unified and cohesive community looking to the next two centuries; and
- (e) that the State Government support a bipartisan approach which funds and coordinates an appropriate program of works and events to mark the bicentenaries in a manner which involves and respects the contributions of all Western Australians.

#### **12. Elder Abuse** (*Notice given 27 February 2024*)

Hon Nick Goiran: To move —

- (a) reminds the WA Labor Government that its January 2017 election manifesto on responding to elder abuse promised that it would "expedite" amendments to the law surrounding enduring powers of attorney and guardianship;
- (b) notes that on 13 September 2017 the Legislative Council established, on the motion of the Opposition, the Select Committee into Elder Abuse;
- (c) reminds the Government that the Select Committee's 24th recommendation in its 2018 Final Report called on it to "act as a matter of urgency";
- (d) notes that more than 7 years have passed since the election promise was made;
- (e) expresses its deep concern about the impact on victims of elder abuse given its prevalence in our State; and
- (f) calls on the Government to apologise for breaking trust with the victims, the electors and the Parliament, and to make amends without any further delay.

#### **13.** Home Ownership (Notice given 27 February 2024)

Hon Tjorn Sibma: To move —

That this House –

- (a) commits to the desirability of home ownership as a critical policy objective for any responsible Government;
- (b) that home ownership must remain a plausible and achievable goal for people so that an individual earning a median income should realistically be capable of purchasing a median-priced dwelling over the long run of economic and property price cycles;
- (c) acknowledge the many forms and sources of policy challenges and impediments to home ownership facing the community of Western Australia; and
- (d) note with alarm that these challenges and impediments to home ownership are disproportionately impacting younger people.

1. Standing Committee on Environment and Public Affairs — Report 61 — Terms of Reference: Inquiry into past forced adoptive policies and practices (Notice given 22 February 2023)

Resolution of the Committee on 22 February 2023 to commence an Inquiry into the past adoptive policies and practices of the twentieth century, notably the years between 1939 and 1980. In particular, the Committee will seek to —

(1) understand the lived experiences of those affected by historical forced adoption practices

- (3) identify what measures are currently available to assist persons experiencing distress, their effectiveness, and how those persons may be supported further
- (4) consider any other matter that arises during the course of the inquiry deemed to be relevant by the Committee.
