Governing Council

At the commencement of the year, the Governing Council comprised eleven members who were appointed by the Minister for Training. During the year, the Council invited the Chair of the Aboriginal Employment, Education and Training Committee (AEETC), Ms Debra Nolan to attend Council meetings and provide a formal liaison between the Governing Council and the AEETC.

Council met every two months and held five meetings during the year. In addition, each member participated in one of two Council Committees: the Planning and Development Committee and Performance and Audit Committee. The members of the Council provided invaluable service and support to the College and willing gave up their time and effort in its interests. Council members attended several functions throughout the year, which marked important milestones for the college. This included:

- Welcoming the *Film and Television Institute* and *Animation Works* to the Fremantle e-Tech Centre and celebrating the partnership arrangement established between the providers
- Actively engaging in the Industry Advisory Committees that were appointed to each of the Centres of Specialisation.
