### **COMMITTEE'S FUNCTIONS AND POWERS**

On 25 November 2008 the Legislative Council concurred with a resolution of the Legislative Assembly to establish the Joint Standing Committee on the Corruption and Crime Commission.

The Joint Standing Committee's functions and powers are defined in the Legislative Assembly's Standing Orders 288-292 and other Assembly Standing Orders relating to standing and select committees, as far as they can be applied. Certain standing orders of the Legislative Council also apply.

It is the function of the Joint Standing Committee to -

- (a) monitor and report to Parliament on the exercise of the functions of the Corruption and Crime Commission and the Parliamentary Inspector of the Corruption and Crime Commission:
- (b) inquire into, and report to Parliament on the means by which corruption prevention practices may be enhanced within the public sector; and
- (c) carry out any other functions conferred on the Committee under the *Corruption and Crime Commission Act 2003*.

The Committee consists of four members, two from the Legislative Assembly and two from the Legislative Council.

### CHAIRMAN'S FOREWORD

In the previous reporting period the former Committee was actively involved in facilitating a resolution of the issues in dispute between Mr Malcolm McCusker, Parliamentary Inspector and the Commissioner of the Corruption and Crime Commission (CCC). The former Committee ceased to exist when the Legislative Assembly was prorogued and dissolved on Thursday, 7 August 2008.

On 26 September 2008 the CCC tabled its report entitled Report on the Investigation of Alleged Misconduct Concerning Mr Stephen Lee, Mayor of City of Cockburn ('CCC Lee Report').

The current Joint Standing Committee on the Corruption and Crime Commission of the 38th Parliament ('the Committee') was established on 25 November 2008. The Committee resolved on 4 December 2008 to continue the work of the former Committee and to hold a formal inquiry into the functions, powers and responsibilities of the CCC and the Parliamentary Inspector as they pertain to each other.

On 18 December 2008 the CCC made an urgent ex parte application to the Supreme Court of Western Australia seeking an injunction to restrain the Parliamentary Inspector from presenting or tabling his proposed report which was critical of the CCC Lee Report. The application for an injunction failed and the Parliamentary Inspector tabled his report on 24 December 2008. The Committee urgently convened and on 24 December 2008 tabled its first report of the 38th Parliament entitled *Parliamentary Inspector's Report Concerning Mr Stephen Lee*.

On 4 February 2009 the Committee hosted a day long workshop attended by:

- the Hon Len Roberts-Smith RFD QC, Commissioner
- Mr Christopher Steytler QC, Parliamentary Inspector
- Mr Malcolm McCusker AO QC, former Parliamentary Inspector
- Mr Ken Martin QC, Acting Parliamentary Inspector
- Ms Gail Archer SC, Acting Commissioner
- Mr Murray Alder, Principal Legal Officer of the Office of the Parliamentary Inspector.

Following the workshop the litigation between Mr McCusker and the CCC was discontinued on 6 February 2009.

In February 2009 the Committee travelled to Brisbane to gather evidence from the Queensland equivalents to the Commissioner and the Parliamentary Inspector, as well as other officials.

On 16 February 2009 the Committee held a public hearing with the Commissioner.

On 19 March 2009 the Committee tabled its second report entitled *Report on the Relationship* between the Parliamentary Inspector and the Commissioner of the Corruption and Crime Commission.

On 7 May 2009 the Committee tabled its third report entitled *Robert Bilos*.

On 18 June 2009 the Committee tabled its fourth report entitled *Corruption and Crime Commission's Response to the Select Committee into the Police Raid on the Sunday Times Report No 1*.

### 1.4 Investigative Travel

In February 2009 the Committee travelled to Queensland for a series of briefings pertaining to the Committee's inquiry into the relationship between the Parliamentary Inspector and the Commissioner of the Corruption and Crime Commission.

In Queensland, the Committee was briefed by the Chairperson and Parliamentary Commissioner of the Crime and Misconduct Commission, the Queensland Public Interest Monitor, the Secretariat of the Parliamentary Committee on the Crime and Misconduct Commission, and a representative of the Queensland Misconduct Tribunal. This series of briefings informed the Committee's second Report to the 38<sup>th</sup> Parliament of Western Australia, the *Report on the Relationship between the Parliamentary Inspector and the Commissioner of the Corruption and Crime Commission.* 

The specific individuals the Committee met with in Brisbane are listed above in Table 1.3.

#### 1.5 Reports Tabled

#### CHAPTER 2 FINANCIAL STATEMENT

The Joint Standing Committee on the Corruption and Crime Commission has a nominal administrative budget of \$15,000 which is funded out of the budget of the Legislative Assembly. Approval for major expenditure occurs on a case-by-case basis and is subject to the approval of the Speaker.

The Committee is required in accordance with Standing Order 276 to detail expenditure for the financial year 1 July 2008 – 30 June 2009. The Legislative Assembly dissolved on 7 August 2008, therefore, two Joint Standing Committees on the Corruption and Crime Commission operated during this financial year. Whilst the current Committee of the 38<sup>th</sup> Parliament tenders the financial figures below, the Legislative Assembly has provided those pertaining to the Joint Standing Committee on the Corruption and Crime Commission of the 37<sup>th</sup> Parliament.
